

This Annual Report for the year 2005-06 is the seventh in the series successfully brought out by the Directorate General of Anti-Dumping and Allied Duties, Ministry of Commerce & Industry, Government of India. It is a matter of great satisfaction that the Annual Report of DGAD by now has become a document which is being referred to by all the interested parties and stake holders for authentic information.

As in the case of earlier reports, this document apart from providing information about legal framework under which the Designated Authority operates, also seeks to give information about trends in the anti-dumping investigations, updated information on investigations initiated by the Authority over the years and a host of other related activities carried out by the Directorate for creating awareness among the stake holders, through seminars etc.

There has been a decline in the number of fresh investigations in India. It is in line with the global trend which has been registering a decline for the last 4 consecutive years. During the year 2005, DGAD had initiated 11 Anti-dumping investigations besides 4 mid-term reviews, 5 sunset reviews and 3 new shipper reviews.

The Directorate has been actively participating in the ongoing deliberations of the Negotiating Group on Rules of WTO. The thrust of these negotiations is to keep costs and administrative burdens low, tighten disciplines, and to elaborate Rules where non exists. The outcome of these negotiations would result in greater transparency, and offer a level playing field in global trading arena.

The officers and staff of the Directorate have put in their best efforts to bring out this document. I place on record my deep appreciation of the excellent work done by them throughout the year in terms of improving and ensuring quality of work and timeliness for completion of the investigations.

INTRODUCTION

Introduction

The World Trade Organisation (WTO) celebrated its tenth anniversary in January 2005, marking ten years of the entry into force of the Uruguay Round agreements signed at Marrakesh in 1994. Globalisation has now become an intrinsic part of “the lexicon of modern discourse on world affairs” and economic co-existence and integration into the world economy through a rule-based system of trade has generally gained acceptance as a catalyst for prospective growth and prosperity.

According to the World Trade Report 2005, global GDP growth was 4% in 2004. South America, Asia and the Commonwealth of Independent States recorded above-average growth rates at 6%, 7% and 8% respectively, providing a solid foundation for growth in trade. Real merchandise trade grew by 9%, the highest rate since 2000, with all regions sharing in the trade expansion and Africa, South & Central America, Asia and the CIS recording growth in double digits. World goods exports grew at 21% to \$8.88 trillion, while commercial services trade grew at 16% to \$2.1 trillion. Within this overall performance, Asia’s goods exports rose by 25% to \$2.39 trillion and its commercial services exports by 21% to \$0.44 trillion, but its dollar import value grew faster than the export value for both goods and services.

Critics of globalization argue that open trade has had a debilitating impact on both the rich and poor countries. While on the one hand, trade with poor countries have depressed prices and real wages of labour-intensive products in the rich countries, on the other, large volumes of relatively low-priced imports to less developed, newly open economies lacking adjustment mechanisms have resulted in worker lay-offs and social strain on their communities. However, the statistics depicted in the World Trade Report 2005 show that trade is a crucial growing component of economic activity, and its continuance could bring stability and contribute to peace by linking different regions of the globe.

Trade defence measures allowed under WTO

Perceptions of fairness and a level playing field in global trading vary, depending on the perspectives from which

viewed. The WTO sets out strict disciplines under which governments may choose to respond to business and other interest groups so that the effective working of its rule-based system through the market provides security and predictability, reduces risks of proposed ventures and enhances productivity and welfare.

Trade defence measures allowed under the WTO are the Agreement on Implementation of Article VI of the General Agreement on Tariffs and Trade, 1994 or the Anti-dumping agreement (ADA), the Agreement on Subsidies and Countervailing Measures (ASCM) and the Safeguards Agreement. This report focuses on dumping and measures against dumping.

Simply stated, dumping is a form of international price discrimination which is said to occur when a product is exported at a price lower than what is normally charged in the home market. As such, though condemned if it causes injury, dumping *per se* is not prohibited, as the GATT only provides for a mechanism to **governments** to respond. Hence, importing countries are authorized to take measures to offset injurious dumping if they wish, subject to the conditions laid down under the ADA on how governments can/cannot react to dumping. Remedial action generally involves charging extra import duty on that product from the exporting country to bring its price closer to the **normal value** to remove the injury to the domestic industry in the importing country.

Global over-view of Anti-dumping

On the global front, anti-dumping and countervailing measures initiated during the last ten years 1995-2004 reveal the trend earlier prevalent among the Members to be active users of trade defence measures, with developing countries coming to the forefront. Removal of quantitative restrictions, lowering of tariffs by developing countries and the global slowdown in the past years has led to higher incidence of trade remedy measures. *But developed countries are equally vigilant, as evidenced by the reaction in the US to business process outsourcing to*

India and in the EU as well as the US to Chinese textile imports after the phase-out of the Agreement on Textiles and Clothing early in 2005. Nonetheless, an overview of measures taken by WTO Members post- 2000 indicates a decline in the number of cases.

The latest WTO Report on Anti-dumping confirms the declining trend. In the first half of 2005, 15 Members

reported initiating 96 new investigations, 21 of these being opened by developed countries and 75 by developing countries, while 12 Members applied 53 new final measures, 24 being applied by developed countries and 29 by developing countries. Corresponding figures in 2004 were 106 initiations of which 66 were by developing countries and 58 new final measures of which 35 were by developing countries.

Over the period 1995 to mid 2005, maximum anti-dumping investigations were initiated against Chinese products followed by products from Korea and from USA among countries having 100 or nearly AD initiations against their products. Those from Chinese Taipei, Japan, India and Indonesia followed, with Thailand and Russia bringing up the rear. The position varied in terms of the number of measures actually applied. While China and Korea maintained their lead position in terms of the largest number of measures applied against their products, Chinese Taipei and USA interchanged their ranking, followed by Japanese, Russian, Thai, Indian and Indonesian products, in that order. Totally, 2743 anti-dumping investigations were initiated over the whole time span.

Importing countries that initiated the maximum anti-dumping measures were (in descending order), India, USA, the EC, Argentina, South Africa, Australia and Canada with Brazil and China PR holding the last two positions. In terms of AD measures applied, the same countries maintained their lead, Canada and Australia interchanging ranks. Over 1995-mid 2005, only 1729 measures, representing 63% of total initiations, were actually applied.

Coming to the latest statistics on anti-dumping, in the first half of 2005, South Africa reported the maximum number of AD initiations at 17, followed by EC with 15, India, 13 and China, 11. The initiations reported by South Africa and India were triple those reported in the first half of 2004. The US has surprisingly dropped from first place in 2004

with 21 initiations to 7th place in 2005 with just 4 initiations. China has had 22 initiations directed at its exports, Chinese Taipei, India and the US following with 9, 8 and 7 initiations respectively. Products reporting new investigations were plastics with 25 initiations - China, South Africa, India and Malaysia together accounting for 21 initiations- followed by chemicals and base metals with 16 initiations each.

As regards application of new final anti-dumping measures in the same period, the US was in the lead with 13, followed by China with 10 and India with 7. Chinese products were the most frequent subject of new

measures - 18 - followed by those from the US and Korea. Products in the chemical sector were subject to 14 of the 53 new measures applied - China and Malaysia accounting for 4 and 3 respectively - followed by those in the base metals and machinery sector with 7 new measures each and the live animals and textile sectors with 6 new measures each.

The table below shows the countries that have initiated and applied the maximum number of anti-dumping measures in the current decade, the figures before the slash sign indicating initiations, and those after, the

A look at the table shows that from 2000 till mid 2005, the total number of anti-dumping measures initiated touched a peak of 364 in 2001 and fell to 212 in 2004. In contrast, the number actually applied peaked at 232 in 2000 and reached their nadir of 151 in 2004. In the current half year period, as already seen, the initiations

were 96 and the applied measures, 53. In all cases, the number of measures initiated and applied has shown a fluctuating trend.

The table showing anti-dumping initiations & measures classified by importing countries shows a different picture.

India's anti-dumping initiations were 81 in 2002 at the peak and touched a low of 21 in 2004. Actual measures applied ranged from a high of 64 to a low of 29 over 2002-04. In the US, the peak of initiations was 75 in

2001 with a low of applied measures at 12 in 2002. India is thus seen to be a very active user of anti-dumping measures, followed by the US, though the EC is seen to step up on the initiations in the past two years.

The maximum number of anti-dumping initiations and measures applied has been on base metals and articles of base metals followed by chemical products and plastic & rubber products. Other sectors that attracted anti-dumping initiations and measures were machinery and appliances, textile and wood & wood products. However, over the period, it can be observed that initiations against chemical products have begun to exceed those against base metals and it is likely that this trend would continue as the pharmaceutical and chemical companies across the world battle for an increasing share of this very lucrative market.

Institution of Anti-dumping Legislation in India

In line with the requirements, the national legislation on

Anti-dumping was enacted in India in 1985, with the first case against dumping being initiated in 1992. However, the Directorate General of Anti-dumping and Allied Duties (DGAD) was formally established in the Department of Commerce only in April, 1998. It is an officer-oriented unit, consisting mainly of officers drawn from the Indian Trade Service, the Indian Cost Accounts Service and the Indian Economic Service. The DGAD investigated about 11 complaints against dumping in 2005-06 (upto December) and took action in 4 cases.

Hong Kong Ministerial, 2005: Negotiations to clarify and improve disciplines

The Negotiating Group on Rules (NGR) was established by the Trade Negotiations Committee in Feb, 2002,

“rules” in the Doha Declaration covering those on anti-dumping (Article VI of GATT), subsidies and countervailing measures and regional trade agreements. The negotiations were to clarify and improve disciplines under the anti-dumping and subsidies agreements, attention being paid to the needs of the developing members.

There were three phase of negotiations: In the first phase, members tabled 141 submissions on the provisions for clarification and improvement, most of these relating to the anti-dumping agreement. In the second phase after Cancun, more detailed and specific proposals were considered in informal sessions of the group, to have a clearer idea of the proposals and assess the likely degree of support for them. The third phase of negotiations in 2005 included bilateral and plurilateral consultations for rigorous consideration of the legal text of the proposals. A technical group was set up by the Chairman, NGR to work on a standard anti-dumping questionnaire to reduce costs and increase predictability for the investigating authorities and the exporters. The basic thrust was to keep costs and administrative burdens low, tighten disciplines, elaborate rules where none exists and operationalize Article 15 relating to developing country members. Similarly in the agreement on subsidies, proposals received concerned subsidy discipline and its calculation for countervailing measures.

A group of 15 participants consisting of Brazil, Chile, Columbia, Costa Rica, Hong Kong, China, Israel, Japan, Republic of Korea, Mexico, Norway, Singapore, Switzerland, Chinese Taipei, Thailand and Turkey constituted “Friends of Anti-dumping Negotiations” (FANs) and tabled a number of proposals.

Annex D of the Hong Kong Ministerial Declaration stress that achievements on the Rules mandate would be important to the development of the trading system and the overall balance of results in the Doha development

agenda (DDA). The ADA negotiation were to clarify and improve the rules regarding (a) determinations of dumping, injury and causation, and the application of measures; (b) procedures governing the initiation, conduct and completion of anti-dumping investigations, including with a view to strengthening due process and enhancing transparency; and c) the level, scope and duration of measures, including duty assessment, interim and new shipper reviews, sunset, and anti-circumvention proceedings. These proposals and those to be submitted would be discussed even after the Hong Kong Ministerial Conference, to facilitate preparation of a consolidated text of these agreements as the basis for the final stage of negotiations by the 2006 end date for the Doha Round.

Other activities of the DGAD

The DGAD conducted seminars at different locations of the country in 2005-06 to bring about awareness among the domestic industry, the exporters and the importers, the downstream users of domestic goods regarding the rules and procedures, the obligations under the WTO, etc.

This Annual Report on the working of the Directorate General is the seventh in the series. It contains latest information on the details of the anti-dumping investigations initiated and applied by DGAD during 2005-06 and the status of the cases at different stages of investigation. There has been no case of anti-subsidy action during this period. The legal framework underlying DGAD functioning, status of cases of anti-dumping and subsidies and the WTO negotiations are contained as separate chapters in the report. Chapter-2

Legal Framework for Anti-dumping and Countervailing Measures

LEGAL FRAMEWORK FOR ANTI-DUMPING AND COUNTERVAILING MEASURES

Legal Framework for Anti-dumping and Countervailing Measures

2.1 National Law

The legal framework for imposing anti-dumping and countervailing measures in India was put in place in 1982 when Sections 9, 9A, 9B and 9C were added to the Customs Tariff Act, 1975. However, Customs Tariff (Identification, Assessment and Collection of Duty or Additional duty on Dumped Articles and for Determination of Injury) Rules and Customs Tariff (Identification, Assessment and Collection of Duty or Additional duty on Bounty-fed Articles and for Determination of Injury) Rules, which provided detailed provisions for conducting investigations and imposing anti-dumping and countervailing duties, were notified in 1985.

After the signing of the legal texts for the Uruguay Round Negotiations under GATT, the Sections 9, 9A, 9B and 9C of the Custom Tariff Act, 1975 were amended on 1st January 1995 to bring the legal provisions in India in line with the WTO Agreement on Implementation of Article VI of GATT 1994 (commonly known as Anti-Dumping Agreement) and WTO Agreement on Subsidies and Countervailing Measures. Customs Tariff (Identification, Assessment and Collection of Anti-Dumping Duty on Dumped Articles and for Determination of Injury) Rules, 1995 and Customs Tariff (Identification, Assessment and Collection of Countervailing Duty on Subsidised Articles and for Determination of Injury) Rules, 1995 were introduced after repealing the earlier Rules. These Rules are commonly known as Anti-Dumping Rules and Countervailing Duty Rules, respectively. Anti-dumping

Rules, 1995 were amended subsequently in July 1999 vide notification No.44/1999-NT Customs; in May 2001 vide notification No.28/2001-NT Customs, in January 2002 vide notification No.1/2002-NT Customs and in November 2003 vide notification No. 101/2003- NT Customs.

2.2 Designated Authority

The Designated Authority is appointed under Rule 3 of the Anti-dumping Rules and Countervailing Duty Rules. The anti-dumping & countervailing measures are administered in India by the Directorate General of Anti-dumping and Allied Duties which was set up on 13th April 1998. The Designated Authority's function is to conduct the anti-dumping and anti-subsidy/ countervailing duty investigations and make recommendations to the Central Government for imposition of anti-dumping or countervailing measures where appropriate. These duties are finally imposed/ levied (and collected) by the Department of Revenue, Ministry of Finance through a Notification. Thus, while the Directorate General of Anti Dumping and Allied Duties in the Department of Commerce recommends the anti-dumping/countervailing duty, it is the Department of Revenue, Ministry of Finance, which actually levies the duties. An appeal, if any, against the order of determination or review thereof regarding the existence, degree and effect of any subsidy or dumping in relation to import of any article lies before the Customs, Excise & Service Tax Appellate Tribunal (CESTAT-formerly known as CEGAT) and thereafter to the Supreme Court of India. However, various High Courts of the country also hear these matters under their writ jurisdiction.

Chapter-3

Details of Anti-dumping Investigations

DETAILS OF ANTI-DUMPING INVESTIGATIONS

The Directorate General of Anti-Dumping and Allied Duties (DGAD) received 24 applications during the year 2005 from the domestic producers alleging dumping of various products causing injury to the domestic industry. After scrutiny of these applications, the DGAD accepted 11 applications for initiation of investigation. Out of the remaining applications, 6 have not been accepted due to lack of sufficient evidence and documentation. 7 applications are under scrutiny at the end of the reporting period.

The first anti-dumping investigation in India was initiated in 1992. During the period from 1992 to 2005, the DGAD received large number of applications for initiating anti-dumping investigations. After examination of these applications, anti-dumping investigations were initiated in 188 cases. Between 1997-2005, 49 applications were not accepted by the DGAD for various reasons.

Major product categories for which anti-dumping applications have been filed by the domestic industry pertain to chemicals & petrochemicals followed by pharmaceuticals, steel & other metals and textiles/fibers/yarns. The countries / customs territories involved are mainly China PR, the members of the European Union, Korea RP and Chinese Taipei. During this period, 188 anti-dumping cases were investigated involving 35 members of WTO (including the EU as a single member of WTO).

3.1 DETAILS OF INVESTIGATIONS INITIATED BY THE DGAD SINCE 1992:

a. Fresh Cases :

During the period from 1992 to 2005, the DGAD initiated 188 investigations. Status of these investigations as on 31.12.2005 is given in the table below:-

3.2 DETAILS OF THE INVESTIGATIONS INITIATED BY THE DGAD DURING THE YEAR 2005:

a. Fresh Cases :

During 2005, the DGAD initiated 11 investigations. All these cases are currently under investigation* for issue of preliminary/final findings.

* The Anti-dumping Rules provide for completion of investigation normally within 12 months from the date of initiation extendable upto 18 months under special circumstances. This period was not over as on 31.12.2005 in the cases initiated during the year 2005.

b. Review Cases:

During the year 2005 the DGAD initiated 12 reviews of various natures and several reviews initiated in the proceeding years were also completed during this period. The break-up of these review cases is as follows:

3.3 CESTAT / COURT CASES:

During the period from 1992 to end of December 2005, 87 appeals were filed by various interested parties in the Customs Excise and Service Tax Appellate Tribunal (CESTAT), out of which decision has been taken by CESTAT in 64 cases. 41 cases have been decided in favour of the Designated Authority. Findings of the Designated Authority have been modified in 15 cases and findings have been quashed by CESTAT in 8 cases.

During the same period, 53 writ petitions were filed in various High Courts. Decision of the High Courts has

been in favour of the Designated Authority in 34 cases. 3 cases has been decided against DGAD and 16 cases are pending for orders.

21 appeals were filed by the interested parties in the Supreme Court since 1992. Out of the 21 appeals before it, the Supreme Court has upheld the findings of the Designated Authority in 7 cases. In 1 case, findings of Designated Authority has been set aside and 2 cases have been remanded back to CESTAT for decision on merit. 11 matter are pending for orders.

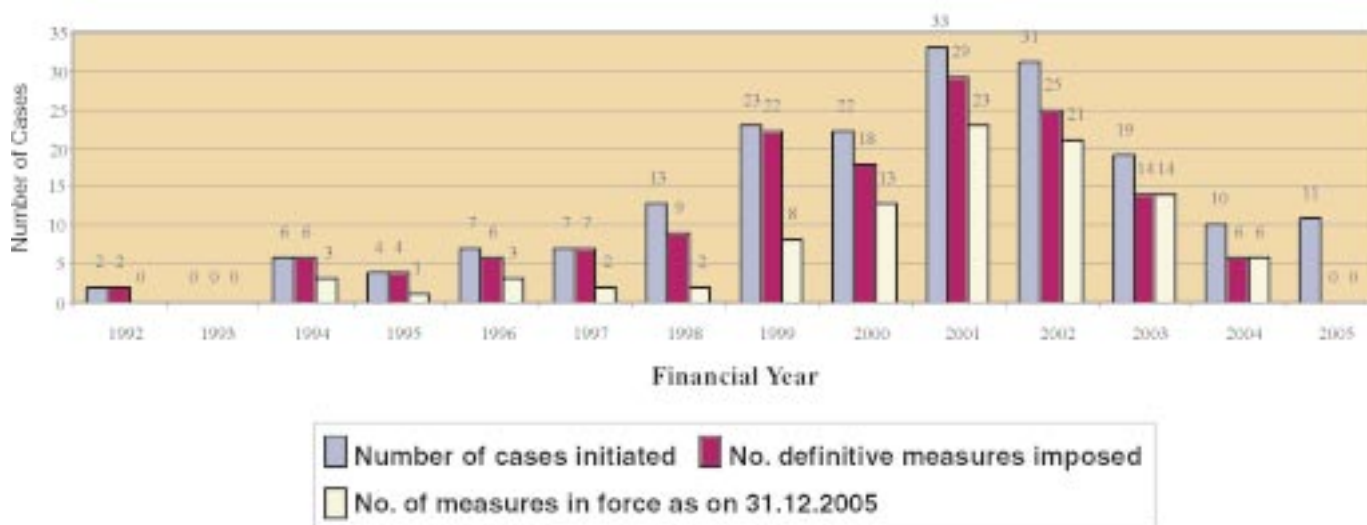

Year-wise Break-up of Anti-Dumping Cases



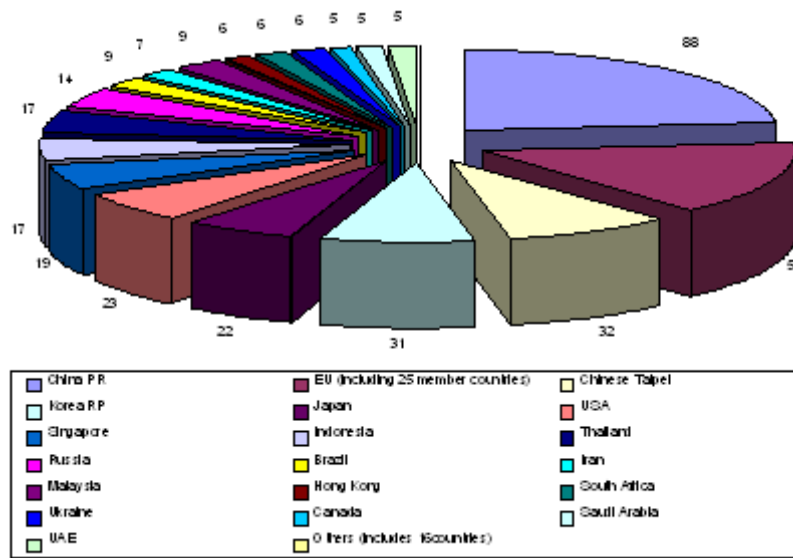

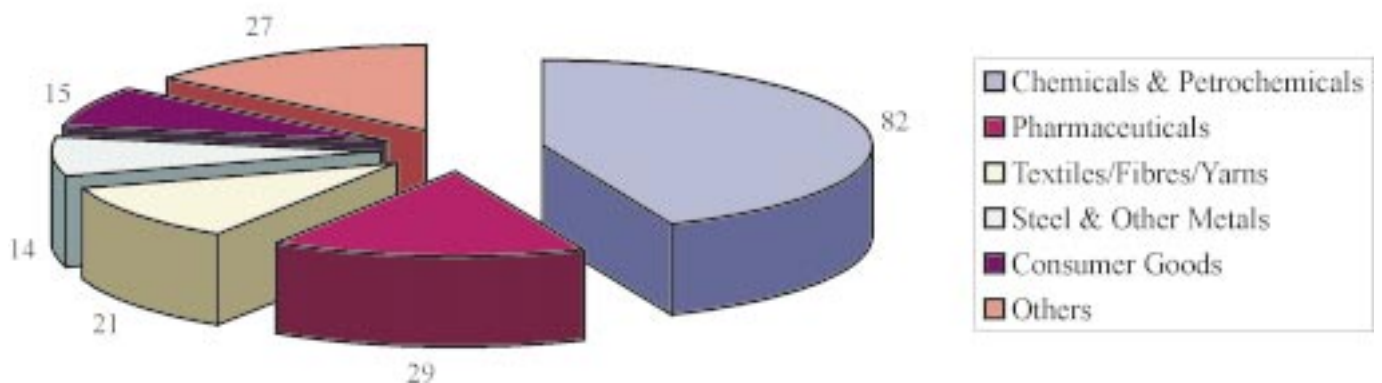
Share of anti-dumping initiations - Country wise

INTERACTION & FACILITATION DURING 2005-06

Anti-dumping and countervailing measures are trade defence instruments that may be used by member countries to deal with the import of goods that are engaged in unfair competition. These measures allow importing members to provide their domestic industries with a level playing field against fluctuations in trading patterns due to import of dumped/subsidized goods. These policy instruments have found wide acceptance among the WTO members.

In an anti-dumping investigation, a member nation imposes an anti-dumping duty against imported goods only when the export prices are lower than normal values and when a causal link is established between the dumping and the injury suffered by the competing domestic industry. Therefore, a detailed investigation has to be conducted within the specified parameters laid down in the national legislation of India which is in consonance with the WTO Agreement on Anti Dumping (ADA). As a trade remedial measure, these investigations involve intricate issues and the procedures required to be followed are both complex and elaborate in nature. The results of an investigation would have an important bearing not only on the trade of the particular commodity/like article (which is the subject matter of an investigation) but also on the various interested parties whether domestic industry, user industry/association or the concerned exporters.

A countervailing duty may be imposed not exceeding the amount of a subsidy which is bestowed directly or indirectly by any country or territory, upon the manufacture or production therein or exportation therefrom of any article into India. Sections 9, 9B and 9C of the Customs Tariff Act (as amended in 1995 and thereafter) framed in pursuance of the WTO Agreement on SCM form the legal basis for Subsidies and Countervailing Measures investigations. The Customs Tariff (Identification, Assessment and Collection of Countervailing Duty on Subsidised Articles and for Determination of Injury) Rules, 1995 contain the operational provisions.

To enhance transparency and bring about greater predictability and awareness, the domestic and user industries are required to be enlightened regarding the data required to be filed in a fully documented application and in response to the importers questionnaire before the Designated Authority. Information was disseminated on the various concepts and legal and operational aspects of trade remedial measures as well as on the administrative mechanism available in India. This was done through various meetings and interactive sessions with different segments of industry and other organisations in the course of 2005-06 as detailed below.

4.1 Visits of Foreign Delegations

A meeting was held with Chinese delegation headed by Mr. Huang Yong Shi, Deputy Director General, Department of Foreign Trade and Economic Cooperation, Huandong Province on 1st July 2005 with DGAD officers. Meeting was chaired by Director (MB). During the meeting, information was exchanged on trade trends on India's Anti-dumping Legislation, procedures and organisation set up for trade remedies.

4.2 Seminars and Workshops

- (a) The DGAD participated in several interactive sessions with various chambers of commerce and industry, academic and research institutions, manufacturers' associations, training institutions etc. for disseminating information and issuing clarifications on trade remedial measures.
- (b) A workshop on proposed amendments in Customs Tariff Act and CVD Rules was jointly organised by Trade Policy Division and Directorate General of Anti-Dumping and Allied Duties on 9th September 2005 at the Taj Mahal Hotel, New Delhi. Around 50 persons attended the Workshop which included advocates, officers from the Ministry of External Affairs, Department of Revenue, Department of

Legal Affairs, etc.

- (c) An International Trade Remedy Seminar was held on 2nd June 2005 in Seoul, Korea. This Seminar was attended by Shri A.K. Gautam, Director, in the DGAD, Department of Commerce.
- (d) The DGAD has been holding seminars/conferences at important cities in the country to sensitize and familiarize the domestic industry/exporter/user industry with the policy framework and procedural aspects of anti-dumping. With a view to disseminate correct information on anti-dumping, the DGAD organised seminars at important cities such as Ludhiana (19.9.2005) and Kolkata (8.4.2005).

Seminars organised by DGAD in different cities:

(i) Seminar at Ludhiana

The Seminar commenced with inaugural welcome address by Shri R K Dhawan, Chairman, Federation of Indian Export Organisation (FIEO), New Delhi. During his welcome address, he said that the removal of quantitative restrictions and reduction in customs duties has posed a major challenge to Indian manufacturing sector. He added that Indian industry has exhibited its potential in successfully countering the threats that Indian market would be flooded with foreign made goods. Shri V K Gupta, Regional DGFT, welcomed the delegates on behalf of DGFT. He described in detail the historical importance of the place and its future potential in terms of foreign trade.

Dr Christy Fernandez, Additional Secretary and Designated Authority, during his inaugural and keynote address at the seminar, said that dumping of goods/products at cheaper prices is not bad until it affects the industry as a whole. He said that it is the lack of awareness about anti-dumping and anti-subsidy amongst industrialists which should be shunned. However, he said that no anti-dumping duty can be imposed against any exporter, until and unless it is proved that dumping has taken place and it is causing an injury to Indian industry and there is a linkage between dumped imports and injury to the domestic industry.

Lauding the role of exporters in building the Indian economy, he said "these are the exporters whose efforts/exports bring laurels to Indian economy and the country as a whole". He said that the Indian exporters are no way second to none in the world and they would get all the possible support from the concerned department. He said that the main

purpose of the seminar is to have close interaction with various stake holders so that various issues concerning anti dumping are disseminated with trade and industry.

The technical session was taken up by officials of DGAD. The speakers spoke about the key concepts, procedures and practices with regards to Anti Dumping investigations in India, the injury margin and methods of determination of Non injurious price of the domestic industry. Among others who spoke during technical session included Mr. Ajay Sahai, Acting Director General, FIEO who covered the subject of Subsidies and Countervailing duties and its related key concepts including compatibility of various export promotion schemes with Agreement on Subsidies and Countervailing Measurement (ASCM).

There was a Question Answer session following the presentations. Questions were asked regarding practices of the Authority, initiation of Anti dumping investigations, interests of the importers and easy communication (by Website or Email) with the Authority. Members of Polyester filament yarn and Acrylic Yarn Industry amongst others actively participated during the interactive session.

(ii) Seminar at Kolkata

The seminar at Kolkata was held on 08/04/2005 which was jointly organized by FICCI (Federation of Indian Chamber of Commerce & Industry) and DGAD (Directorate General of Anti-Dumping and Allied Duties) in collaboration with export promotion councils. The seminar was attended by officials of DGAD, officials of DGFT and officials of West Bengal apart from participants from industries. Prof B.S.Chimni, Vice Chancellor of West Bengal National University of Juridical Sciences inaugurated the seminar and delivered his inaugural key note address. In his key note address he urged the industry and the exporters to achieve scale-economies and world class production efficiency to remain competitive in the globalised economy. He also cautioned the participants that while the trade remedial instruments can address their concern against unfair trade but these instruments will provide a temporarily relief. He mentioned that though the law relating to the anti dumping has been in place since 1985, today India is one of the major players among the WTO Member countries, using as well as facing anti dumping measures. With the globalisation of trade and opening of economic boundaries, reduction in import tariffs, anti dumping is one of the weapons in the armoury to fight unfair competition. Therefore, this kind of seminars was imperative to disseminate information relating to anti dumping laws, practices and procedure. Shri Manav Majumdar, FICCI, delivering his welcome address,

emphasised the importance of trade defence measures. He also mentioned that in the backdrop of economic liberalisation and the fact that the domestic industry is currently in the state of adjusting itself to a free regime, there is a need to be vigilant as the sheer size of the domestic market can be a temptation for exporting nations to indulge in unfair trade practices. After the inaugural session, technical sessions having two presentations by the officials of the DGAD and speakers from industry deliberated on different aspects of anti dumping & allied matters.

4.3 Facilitation

- (a) The DGAD has looked forward to cooperation from all interested parties in providing the requisite information within the stipulated time and in assisting the Directorate in conducting the investigations in a fair and time bound manner. Towards this end, the office of DGAD can be contacted if any clarification and/or assistance in furnishing the information in the prescribed manner is required either by domestic industry, user industry or exporters.
- (b) The Authority is required to provide timely opportunities to all interested parties to see all information that is relevant to the presentation of their cases, which is not confidential and which is used by the Authority in an anti-dumping investigation. An Initiation Notification states that in terms of Rule 6(7), any interested party may inspect the Public File containing non-confidential version of the evidence submitted by other interested parties. A Public File is maintained by the DGAD and kept open for inspection from the date of the initiation. It contains all non-confidential submissions made by interested parties, which includes copies of the non-confidential application, non-confidential versions of exporters and importers responses to their respective questionnaires, etc.
- (c) The right of inspection of documents is conferred on all the interested parties that includes

complainants, foreign producers/exporters, importers, users and other interested parties. They may inspect these documents personally or through authorised representatives.

4.4 Publications

- (a) For the use of industry associations and individual manufacturers interested in understanding the trade remedial measures, a booklet on 'Anti-Dumping and Anti-Subsidy Measures' in the form of answers to frequently asked questions (FAQs) and a Guide on anti-dumping in which the essential concepts have been explained were published. The revised Exporters Questionnaire is available on the DGAD website of the Ministry of Commerce.
- (b) The Annual Report of the Directorate General of Anti-Dumping & Allied Duties is a publication that contains useful information on legal framework, details of cases, analysis of cases, interaction and facilitation and general information. The Report also provides information on anti-dumping and anti-subsidy cases against exports from India. Two useful booklets like (i) Compendium on Laws & Regulations on Anti-dumping containing relevant provisions on anti-dumping under the Customs Tariff Act, Anti-dumping Rules and the Agreement on implementation of Article VI GATT, 1994 and (ii) Anti-dumping cases in India-Product and Profiles have been published this year.

4.5 Website

The anti-dumping guidelines, application proforma for the domestic industry, questionnaire for importers and exporters and the details of initiation of anti-dumping investigation, preliminary findings and final findings are available on the official web-site viz., <http://commerce.nic.in>. The answers to frequently asked questions on anti-dumping and anti-subsidy measures are also available on this website. The FAQs consist of, inter alia, the meanings of the different concepts, the anti-dumping procedure and miscellaneous matters.

Chapter-5

WTO- Negotiations

5

WTO- NEGOTIATIONS

The Ministerial Declaration adopted on 14th November 2001 in Doha stated the work programme in respect of WTO Rules in paragraph 28 & 29 as under:

"28. In the light of experience and of the increasing application of these instruments by members, we agree to negotiations aimed at clarifying and improving disciplines under the Agreements on Implementation of Article VI of the GATT 1994 and on Subsidies and Countervailing Measures, while preserving the basic concepts, principles and effectiveness of these Agreements and their instruments and objectives, and taking into account the needs of developing and least-developed participants. In the initial phase of the negotiations, participants will indicate the provisions, including disciplines on trade distorting practices, that they seek to clarify and improve in the subsequent phase. In the context of these negotiations, participants shall also aim to clarify and improve WTO disciplines on fisheries subsidies, taking into account the importance of this sector to developing countries. We note that fisheries subsidies are also referred to in paragraph 31.

29. We also agree to negotiations aimed at clarifying and improving disciplines and procedures under the existing WTO provisions applying to regional trade agreements. The negotiations shall take into account the developmental aspects of regional trade agreements."

As a part of the Doha Work Programme, the WTO Negotiating Group on Rules has been considering proposals from various WTO members to clarify and improve existing disciplines of the Anti Dumping Agreement and Agreement on Subsidies and Countervailing Measures (ASCM). The Negotiating Group on Rules held meetings in the months of April, May-June, July, September, October and November 2005 to discuss various proposals furnished by the Members. In the area of anti-dumping, the Negotiating Group on Rules has been discussing proposals on such issues as determinations of injury/causation, the lesser

duty rule, public interest, transparency and due process, interim reviews, sunset, duty assessment, circumvention, the use of facts available, limited examination and all others rates, dispute settlement, the definition of dumped imports, affiliated parties, product under consideration, and the initiation and completion of investigations.

In respect of subsidies and countervailing measures, proposals have been submitted on a number of issues, including the definition of a subsidy, specificity, prohibited subsidies, serious prejudice, export credits and guarantees, and the allocation of benefit.

The proposals generally seek to strengthen disciplines in these two agreements. India has also made four submissions thus far, including a detailed textual proposal submitted in early 2005 on the mandatory application of Lesser Duty Rule.

As regards fisheries subsidies, there is a broad agreement that the Group should strengthen disciplines on subsidies in the fisheries sector, including through the prohibition of certain forms of fisheries subsidies that contribute to overcapacity and over-fishing. Appropriate and effective special and differential treatment for developing and least-developed Members should be an integral part of the fisheries subsidies negotiations, taking into account the importance of this sector to development priorities, poverty reduction, and livelihood and food security concerns;

The Ministerial Declaration of the 6th WTO Ministerial Conference held at Hong Kong in December 2005 recalled the mandates in paragraphs 28 & 29 of the Doha Ministerial Declaration and reaffirmed the commitment to the negotiations on rules as set forth in Annex D of the Declaration (Annexure-I).

In the forthcoming meetings of the Negotiating Group on Rules, the negotiating process may intensify and accelerate on the basis of detailed textual proposals before the Group.

ANNEX D

RULES

I. Anti-Dumping and Subsidies and Countervailing Measures including Fisheries Subsidies

We:

1. *acknowledge* that the achievement of substantial results on all aspects of the Rules mandate, in the form of amendments to the Anti-Dumping (AD) and Subsidies and Countervailing Measures (SCM) Agreements, is important to the development of the rules-based multilateral trading system and to the overall balance of results in the DDA (Doha Development Agenda);
2. *aim* to achieve in the negotiations on Rules further improvements, in particular, to the transparency, predictability and clarity of the relevant disciplines, to the benefit of all Members, including in particular developing and least-developed Members. In this respect, the development dimension of the negotiations must be addressed as an integral part of any outcome;
3. *call on* Participants, in considering possible clarifications and improvements in the area of anti-dumping, to take into account, *inter alia*, (a) the need to avoid the unwarranted use of anti-dumping measures, while preserving the basic concepts, principles and effectiveness of the instrument and its objectives where such measures are warranted; and (b) the desirability of limiting the costs and complexity of proceedings for interested parties and the investigating authorities alike, while strengthening the due process, transparency and predictability of such proceedings and measures;
4. *consider* that negotiations on anti-dumping should, as appropriate, clarify and improve the rules regarding, *inter alia*, (a) determinations of dumping, injury and causation, and the application of measures; (b) procedures governing the initiation, conduct and completion of antidumping investigations, including with a view to strengthening due process and enhancing transparency; and (c) the level, scope and duration of measures, including duty assessment, interim and new shipper reviews, sunset, and anti-circumvention proceedings;
5. *recognize* that negotiations on anti-dumping have intensified and deepened, that Participants are showing a high level of constructive engagement, and that the process of rigorous discussion of the issues based on specific textual proposals for amendment to the AD Agreement has been productive and is a necessary step in achieving the substantial results to which Ministers are committed;
6. *note* that, in the negotiations on anti-dumping, the Negotiating Group on Rules has been discussing in detail proposals on such issues as determinations of injury/causation, the lesser duty rule, public interest, transparency and due process, interim reviews, sunset, duty assessment, circumvention, the use of facts available, limited examination and all others rates, dispute settlement, the definition of dumped imports, affiliated parties, product under consideration, and the initiation and completion of investigations, and that this process of discussing proposals before the Group or yet to be submitted will continue after Hong Kong;
7. *note*, in respect of subsidies and countervailing measures, that while proposals for amendments to the SCM Agreement have been submitted on a number of issues, including the definition of a subsidy, specificity, prohibited subsidies, serious

prejudice, export credits and guarantees, and the allocation of benefit, there is a need to deepen the analysis on the basis of specific textual proposals in order to ensure a balanced outcome in all areas of the Group's mandate;

8. *note* the desirability of applying to both anti-dumping and countervailing measures any clarifications and improvements which are relevant and appropriate to both instruments;

9. *recall* our commitment at Doha to enhancing the mutual supportiveness of trade and environment, note that there is broad agreement that the Group should strengthen disciplines on subsidies in the fisheries sector, including through the prohibition of certain forms of fisheries subsidies that contribute to overcapacity and over-fishing, and *call on* Participants promptly to undertake further detailed work to, inter alia, establish the nature and extent of those disciplines, including transparency and enforceability. Appropriate and effective special and

differential treatment for developing and least-developed Members should be an integral part of the fisheries subsidies negotiations, taking into account the importance of this sector to development priorities, poverty reduction, and livelihood and food security concerns;

10. *direct* the Group to intensify and accelerate the negotiating process in all areas of its mandate, on the basis of detailed textual proposals before the Group or yet to be submitted, and complete the process of analysing proposals by Participants on the AD and SCM Agreements as soon as possible;

11. *mandate* the Chairman to prepare, early enough to assure a timely outcome within the context of the 2006 end date for the Doha Development Agenda and taking account of progress in other areas of the negotiations, consolidated texts of the AD and SCM Agreements that shall be the basis for the final stage of the negotiations.

GENERAL INFORMATION

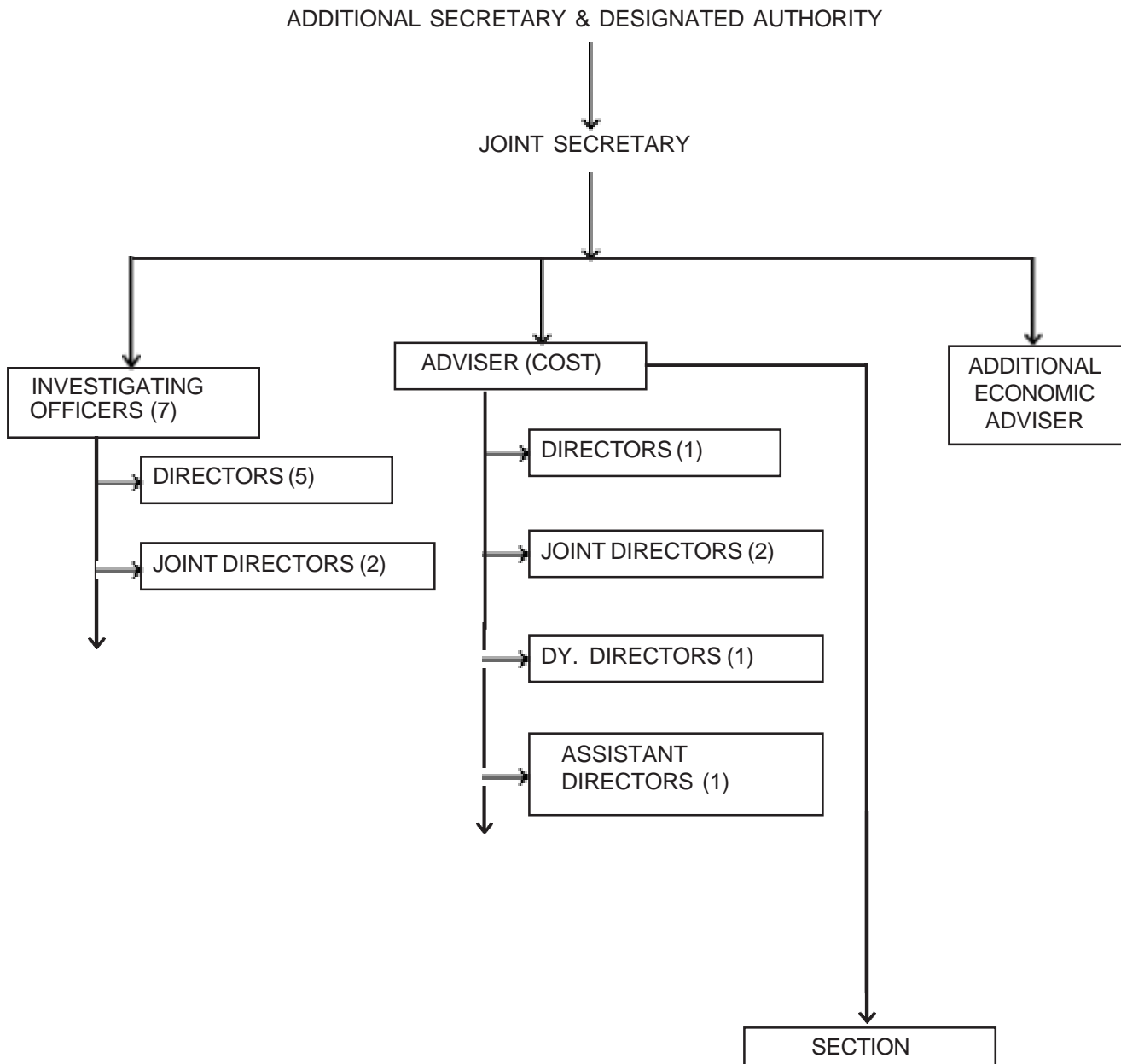
6.1 Introduction

The Directorate General of Anti-Dumping & Allied Duties (DGAD) was established in April, 1998. However, the Designated Authority in the Department of Commerce has been handling anti-dumping cases since 1992. The DGAD is headed by the Designated Authority, an officer of the level of Additional Secretary to the Government of India, who is assisted by an Adviser and an Additional Economic Adviser. There are 7 investigating officers and 5 officers dealing with costing. Besides, there is one Section, which looks after coordination, administration and other matters of the Directorate. Generally, the investigating officers are drawn from Indian Trade Service

and the costing officers from the Indian Cost & Accounts Service.

An effort has been made in the following paragraphs to disseminate information on the organisational set up of the DGAD; to publish the names, telephone numbers and e-mail addresses of the officers; provide addresses of the Directorate General of Foreign Trade (DGFT) Port Offices which are used by the DGAD as communication channels between the Directorate and the Industry; furnish names and addresses of the advocates on the panel of DGAD to defend cases in the Customs Excise & Service Tax Tribunal (CESTAT) and those advocates and consultants who appear before the DGAD in anti-dumping investigations.

Anti-dumping & Anti-subsidy Cases against Indian Exporters



ANTI-DUMPING & ANTI-SUBSIDY CASES AGAINST INDIAN EXPORTERS

Introduction

Exports of certain commodities from India have also faced antidumping and anti-subsidy actions by a number of member countries of the WTO. Though the Directorate General of Antidumping and Allied Duties do not handle the cases initiated by other member countries against India, in order to facilitate availability of information on the antidumping cases against Indian exports, this data has been compiled from various sources, including WTO website. However, the information is based on the data released by WTO up to 30th June 2005.

7.1.1 Year-wise Distribution of Anti-dumping Initiations

Between 1st January 2005 and 30th June 2005, 8 new antidumping investigations were initiated against Indian exports by other member countries of WTO, taking total number of initiations against India, since 1995, to 115 accounting for 4.2% of all AD initiations between 1995-2005. However, a year-to-year comparison, taking into account the AD initiation in the first half of the calendar year indicates a substantial jump in initiations against India. Year-wise distribution of AD initiations against India has been shown below:

During the period Jan-June 2005 8 new AD investigations were initiated by Argentina (1), Egypt (2), South Africa

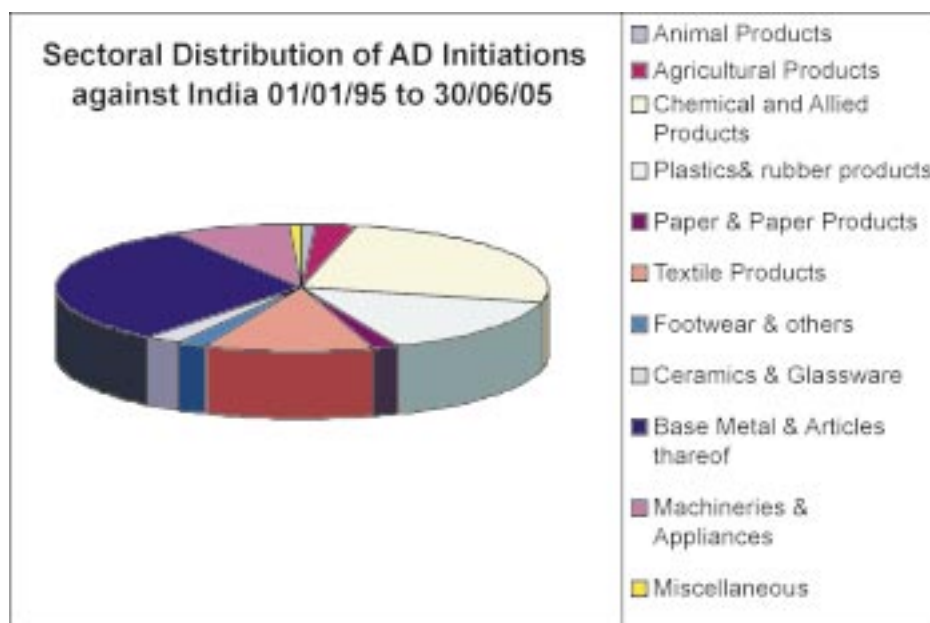

7.1.3 Sectoral Distribution of AD Initiations against India

During the period Jan-June 2005 8 new AD investigations were initiated by Argentina (1), Egypt



Indian exports of base metals, chemicals and textiles continue to be the commodities most frequently investigated by the member countries of WTO. Against 115 antidumping investigations initiated against Indian exports during the period 1995-2005, 35 are against base metals and 29 are against chemical and allied products, followed by Plastics and rubber products (17) and textiles (13).

7.1.4 Measures in force against Indian exports

Against total initiation of 115 cases since 1995, 62 definitive measures have been imposed by various member countries of WTO against Indian exports

accounting for 3.6% of all AD measures in force in the world. Out of 53 new measures imposed by the members of WTO during the first half of 2005 one (1) measure is against the Indian exports imposed by the USA. Year-wise break up of cases are as follows.

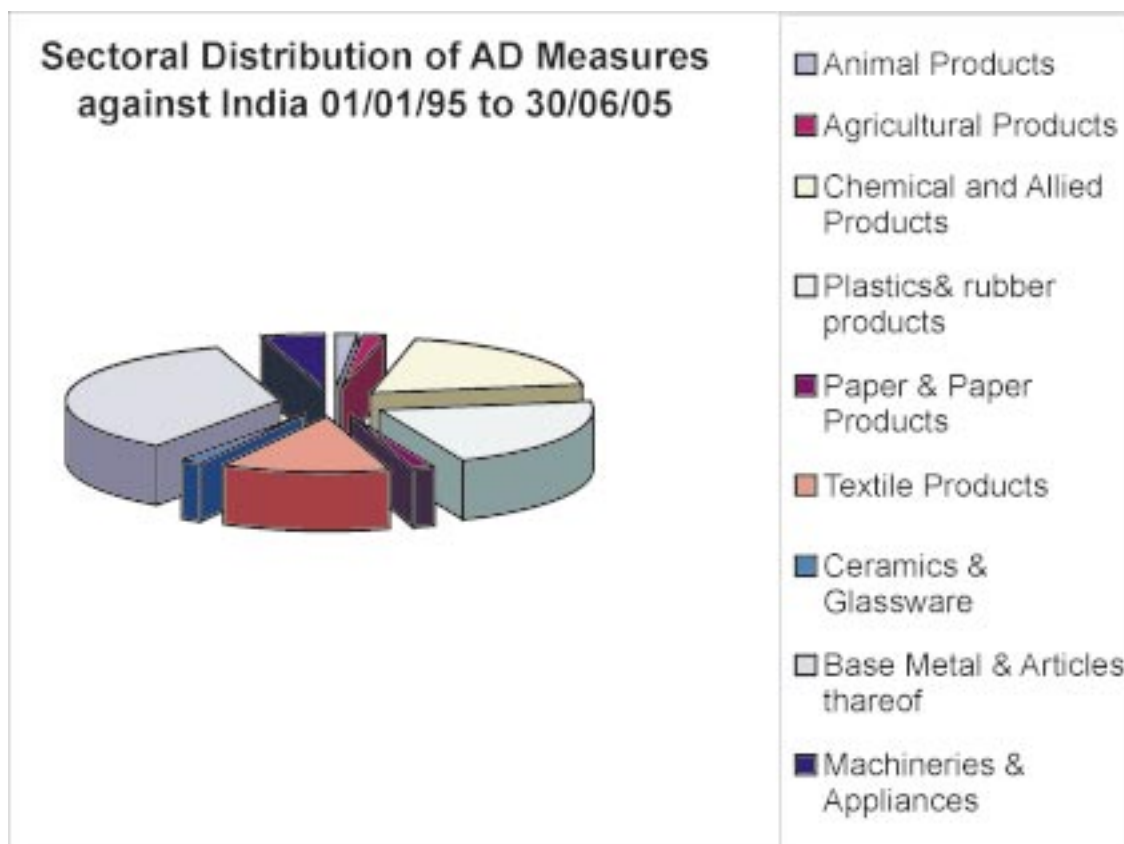

7.1.6 Sectoral distribution of AD measures against Indian exports:

Product wise analysis of AD measures against Indian exports indicates that highest number of anti-dumping cases continue to be on the base metals including steel

products and Engineering products, which account for 32% of the total cases, followed by Chemicals and allied products including drugs and pharmaceuticals, which account for about 25% of all AD measures against India.

7.2.1 Country wise initiations of anti-subsidy cases against India

Indian exports are also facing number of anti-subsidy cases by other member countries of the WTO. In the last one-decade, 41 anti subsidy cases were initiated against Indian exports.

EU, USA, and South Africa accounts for 83% of the anti-subsidy cases initiated against Indian exports. The European Union continues to be the major user with 14 initiations out of total 41 initiations against Indian exports. USA and South Africa follows with 11 and 9 initiations respectively followed by Canada with 5 initiations. Brazil accounts for 5% of the cases with 2 initiations to its credit.

7.2.2 Measures in Force against India

Definitive measures have been imposed in 25 countervailing investigations out of 41 cases initiated against Indian exports by major user of this instrument . The EU has so far imposed measures in 11 cases followed by USA with 6 definitive measures imposed against Indian exports. Canada and South Africa have respectively 4 and 3 measures. Brazil has completed one investigation and imposed measure out of 2 cases initiated so far.

The trend of the last decade shows that around 95% of the anti subsidy cases were initiated after the financial year 1997-98.

7.2.4 Product-wise distribution of Anti-subsidy cases against India:

Engineering including steel products account for 38% of the total cases initiated against Indian exports as highest number of anti-subsidy cases. This is followed by plastic products and Chemicals and allied products including drugs and pharmaceuticals constitutes which account for about 20% each of anti-subsidy initiations against Indian products.
