Major achievements of Department of Commerce during March, 2019.

- On the basis of Quick Estimates on merchandise trade for India released on 15.03.2019, the value of merchandise exports during February 2019 has been USD 26.67 billion as compared to USD 26.03 billion in February 2018, thus, registering a growth of 2.44 per cent. The cumulative exports during April-February 2019 has been estimated at USD 298.47 billion compared to USD 274.21 billion during the corresponding period of last fiscal year, which is a growth of 8.85 percent compared to the same period in last fiscal year.
- During the month of March 2019, permits were issued to export a quantity of 43779.87 MT of coffee as against 43211.71 MT during the corresponding month of previous year, which is an increase of over 1.3% when compared to corresponding month of previous year.
- Under Rubber Plantation Development Scheme (Phase VIII), the Rubber Board, issued 1424 fresh permits covering an area of 759.86Ha and sanctioned subsidy of Rs. 121.88 Lakh during March, 2019.
- Twenty-nine training programmes were conducted under Tappers Skill Development Programme 334 candidates, under Advisory and extension services were trained during the month of March 2019. Under farmer education programmers, 618 programmes were organized with the participation of 13,844 farmers.
- Department of Commerce has done detailed tariff line wise analysis of all 1333 tariff lines of Phase 1 and 5734 tariff lines of Phase 2 and identified a list of tariff lines where India is a net exporter and also having potential to export to U.S. The identified list of tariff lines has been shared with the Export Promotion Councils (EPCs) and Commodity Boards concerned, for

focusing on identified lines to increase India's export to U.S. The NAFTA Division has revived the performance department-wise and identified the commodities where performance is poor and sensitized the departments to take further action to improve the exports.

- During March, 2019 600 Sellers & 4169 buyers have been provided training in GeM.
- Regional Authorities of DGFT issued following Authorizations/Scrips during the month of March, 2019.

- On the eve of closing of financial year, it was ensured that all the funds released were utilized by the stakeholders and overall expenditure on 31.03.2019 was 99.47% of DoC's total outlay.
