• DGTR organized a Level II training programme on trade remedial measures for DGFT and Cost Accounts Service Officers on 24.9.2019 benefitting total 27 participants. DGTR to promote transparency, efficiency and expedited relief to the domestic producers has introduced the online portal(ARTIS). This portal enables the Applicant domestic producer to submit online applications for different trade remedies like anti-dumping duty, safeguard duty and countervailing duty. Applicants can also monitor the current status of their applications through online portal.

- The Tea Board has launched the mobile app "Chai Sahayog" in all tea growing regions of India in September, 2019. The Tea Board published the first draft Indian Tea Genome Sequence of a popular Cultivar (TV-1) in September, 2019.
- The Coffee Board signed a Memorandum of Understanding (MoU) with IIT, Madras for opening of India Coffee House at IIT, Madras.
- The Rubber Board launched a mobile application for domestic NR price collection on 23rd September and inaugurated a Help Desk for manufacturers and dealers of NR on 30th September 2019. The Board, also promoted Good Agricultural Practices such as rainguarding, prophylactic spraying, fertilizer application, tapping defect correction, etc to enhance production and expected that 40% (around 2.5 lakh ha) of tappable area has been rain guarded up to September 2019.
- The Rubber Board organized 409 farmer education programmes with a participation of 10,316 farmers and 498 rubber producers societies meeting benefiting 8,664 farmers and certified 388 plantations having an area 312 ha during September 2019.

- The Rubber Board received 10,150 sale bills during September 2019 from small rubber growers under Rubber Production Incentive Scheme funded by the Government of Kerala and confirmed the bills for effecting payment to growers as price incentive.
- The average auction price of Spice Board for small cardamom during the month of Septermber was Rs.3044.77 per kg. The e-auction centres at Puttady in Kerala and Bodinaykannur in Tamil Nadu have facilitated auction of 1336 tons of cardamom (small) through eauction.
- The quality evaluation laboratories of the Spice Board have analysed a total of 9736 parameters in spice samples during the month of September, 2019. The Spice Board has issued 116 Certificates of Registration as Exporter of Spices (CRES) and 8 cardamom dealer licences during September, 2019.
- The Spice Board conducted a buyer seller meet and open house for small cardamom, black pepper and ginger at Kattappana, Idukki, Kerala on 27.9.2019, wherein more than 228 number of participants consisting of exporters/traders/farmers from various parts of the country were witnessed. The Divisional Office of Spice Board, Agartala also conducted it Second Recognition Prior Learning (RPL) training programme on Organic Production for 30 persons at Lasnkamura Village, West Tripura district from 16th to 18th September, 2019.
- Project Export Promotion Council of India (PEPC) member company M/s Larsen & Toubro Ltd. Oman has been awarded the main work contact of The Mandarin Oriental Muscat by Eagle Hills, Muscat, which involves the construction of the Mandarin Oriental Hotel and the residences at the Mandarin Oriental, Muscat. L&T will oversee the overall construction within the site, which includes a 150-key hotel and 156 units of branded residences, as well as 1622 square meters of retail areas, podium and basement L&T will also undertake the

associated external work services and hard and soft landscaping works.
