- (c) the fresh steps taken by the Government for promotion of GI tagged Nagpur orange and organic citrus products from Maharashtra and Rajasthan?

वाणिज्य एवं उद्योग मंत्रालय में राज्य मंत्री (श्रीमती अनुप्रिया पटेल) THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE AND INDUSTRY (SMT. ANUPRIYA PATEL)

- (a) & (b): Yes, Sir. Promoting exports of citrus fruits and their value-added products is a continuous process. The Agricultural and Processed Food Products Export Development Authority (APEDA) has the mandate to promote exports of these products. Nagpur, Amravati, Wardha districts of Maharashtra and Chindwara, Agar Malwa and Shajapur districts of Madhya Pradesh have been identified as clusters for promotion of export of citrus fruits. District-level cluster committees have been formed in several districts of these clusters to oversee the promotion of exports. APEDA has organised sensitization meetings/programs in the clusters, in association with State departments, State Agriculture Universities, Krishi Vikas Kendras and NABARD, for identification of progressive farmer groups and strengthening the export linkage of FPOs. Capacity building programmes for growers and buyer-seller meets have also been organized. APEDA also provides assistance to exporters of citrus fruits and their value-added products under various components of its export promotion scheme.
- (c): To promote exports of registered GI products of India, including from Maharashtra and Rajasthan, APEDA has organized virtual buyer-seller meets on GI products with USA and UAE. A GI promotion programme and exhibition was also organized at Varanasi. APEDA also promotes the agricultural and food GI products through all its promotional events, including buyer-seller meets, trade fairs etc.

- (a) & (b): In Budget Speech 2020-21, Hon'ble Finance Minister had announced the NIRVIK Scheme for which the Department of Commerce is actively engaged in seeking requisite approvals.
- (c) & (d): In Budget Speech 2020-21, Hon'ble Finance Minister announced plans to set up an Investment Clearance Cell (ICC) that will provide "end to end" facilitation and support to investors, including pre-investment advisory, provide information related to land banks and

facilitate clearance at Centre and State level. The Cell was proposed to operate through an online digital portal.

Subsequently, Department for Promotion of Industry and Internal Trade (DPIIT) along with Invest India initiated the process of developing the portal as a National Single Window System (NSWS). Envisioned as a one-stop for taking all the regulatory approvals and services in the country, NSWS [www.nsws.gov.in] was soft-launched on 22nd September, 2021 by Hon'ble Commerce & Industry Minister.

The national portal integrates the existing clearance systems of various Ministries/ Departments of Government of India and State Governments without disruption to their existing IT portals.

Currently approval of 19 Ministries/Departments and 11 States Single Window Systems have been on-boarded on the NSWS Portal.

- (e): There are no plans currently under consideration of the Government "to release National Logistics Policy to create a single window e-logistics market".
- (f)& (g): In view of the reply at (e) above, questions do not arise.

- (a): Government of India has approved the 'Action Plan for Champion Sectors in Services' to give focused attention to 12 identified Champion Services Sectors. With the identification of 12 Champion Services Sectors, Bureau of Indian Standards (BIS) has set up a dedicated Services Sector Division Council (SSDC) to formulate Indian Standards in various Services Sectors, especially Champion Services Sectors. Currently there are 84 published standards (list at Annexure-I) for various services sectors. Wherever possible, the Indian Standards are harmonized with international standards for ensuring that quality of services match global expectations.
- **(b):** Services export has increased from US\$ 154,311 Million to US\$ 206,090 Million from 2015-16 to 2020-21.
- (c) The export of services sector during the last three years is given in the table below.

- (a): Iron ore production in the country during FY 2019-20, 2020-21 and 2021-22 (up to September) was 246.08 MT (million tonnes), 204.48 MT and 123.87 MT respectively.
- (b): Iron ore is also exported to various countries like China, Indonesia, Oman, South Korea, etc. The iron ore produced in the country is primarily used for local requirements.
- (c) and (d): Government has imposed export duty of 30% on all forms of iron ore except low grade (below 58% Fe content) iron ore comprising lump & fines. Government has also not extended the Long Term Agreement for export of iron ore to Japan and South Korea beyond 31.03.2021 to prioritize the availability of raw material for the domestic steel industry.

- (b) whether the Government is not prepared to deal with the competition in the global market due to declining export of foodgrains;

ANSWER

वाणिज्य एवं उद्योग मंत्रालय में राज्य मंत्री (श्रीमती अनुप्रिया पटेल) THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE AND INDUSTRY (SMT. ANUPRIYA PATEL)

- (a): India's share in the world food grains market, based on the exported values in 2020, is 6.9% (Source: ITC Trade Map calculations based on UN COMTRADE and ITC statistics).
- (b) & (c): Despite the challenges like huge domestic consumption base and high domestic prices vis a vis international prices, India has emerged as the largest exporter of rice and a major exporter of wheat in the world. During the COVID-19 period, India has established itself as a reliable supplier of food grains and other foodstuff. The Agricultural & Processed Food Products Export Development Authority (APEDA), an autonomous organization under the administrative control of the Department of Commerce, has the mandate to promote exports of food grains. APEDA provides assistance to the exporters of food grains under its scheme "Agriculture & Processed Food Export Promotion Scheme of APEDA". The assistance is provided under various components of the scheme viz. Infrastructure Development, Quality Development and Market Development. Export Promotion Forums (EPFs) for Rice and Nutri-Cereals have been set up under the aegis of APEDA. The EPFs strive to identify and anticipate developments pertaining to production and exports of these products, reach out to stakeholders across the entire production/ supply chain of exports and make recommendations for necessary policy interventions and other measures to promote exports.

(d) Promotion of exports of agricultural products, including food grains, is a continuous process. To promote agricultural exports, the Government has introduced a comprehensive Agriculture Export Policy (AEP) to harness export potential of Indian agriculture and raise farmers' income. Department of Commerce has taken several steps to implement the AEP at the State / District level. State specific Action Plans, State Level Monitoring Committees (SLMCs), Nodal Agencies for agricultural exports and Cluster Level Committees have been formed in a number of States. Country and product-specific action plans have also been formulated to promote agricultural exports.

A Farmer Connect Portal has been set up by APEDA for providing a platform for farmers, Farmer-Producer Organizations (FPOs) and cooperatives to interact with exporters. Buyer-seller Meets (BSMs) have been organized in the clusters to provide export-market linkages. Regular interactions, through videoconferences, have been held with the Indian Missions abroad, to assess and exploit export opportunities. Country specific BSMs, through Indian Missions, have also been organized.

The Department of Commerce provides assistance to promote exports including exports of food grains, through several other schemes such as the Trade Infrastructure for Export Scheme (TIES), Market Access Initiatives (MAI) Scheme etc.

(a) & (b): Duty neutralization is provided under Schemes such as Advance Authorization, Rebate of State and Central Taxes and Levies (RoSCTL), Rebate of State Levies (ROSL), Duty Drawback Scheme and Export Promotion Capital Goods (EPCG) Scheme.

Central Board of Indirect Taxes and Customs (CBIC) has introduced 'Manufacture and Other Operations in Warehouse Scheme' under the Customs Act, 1962 wherein a manufacturing unit can import goods (both inputs and capital goods) under customs duty deferment with no interest liability. There is no duty payable if the goods resulting from such operations are exported. Import duty is payable only if the resulting goods are cleared in the domestic market (exbonding). In addition, a procedure for availing the benefit of concessional rate of duty on import of goods for domestic production of goods or for providing services was introduced on 01.07.2017 through Customs (Import of Goods at Concessional Rate of Duty) Rules, 2017.
