- (a) the details of the use/disbursement of the Rs. 1000 crore funds for the welfare of tea garden workers in West Bengal and Assam, allocated in the 2021-22 annual budget;
- (b) whether there is any delay in disbursement of the allocated funds and if so, the reasons therefor;
- (c) whether there is any delay in the release of the subsidy to the tea gardens of North Bengal;
- (d) if so, the details of the subsidies pending as on date;
- (e) the reasons for delay in the payment and expected date of clearing of all pending subsidies; and
- (f) the details of various schemes for the welfare of tea garden workers and their family members being run by the Tea Board/Ministry?

STATEMENT REFERRED TO IN REPLY TO PARTS (a) to (f) OF LOK SABHA STARRED QUESTION NO. 113 FOR ANSWER ON 09th FEBRUARY, 2022 REGARDING “WELFARE OF TEA GARDEN WORKERS”.

(a) to (f): Tea Board has implemented welfare activities under Human Resource Development (HRD) component of the “Tea Development and Promotion Scheme” during the Medium Term Framework period from 2017-18 to 2019-20 and extended till 2020-21, aimed at improving the health and hygiene of workers, education of wards of workers and imparting training to improve skills for growers/workers. The “Tea Development & Promotion Scheme” approved for implementation by Tea Board during the 15th Finance Commission period from 2021-22 to 2025-26 has a component for the welfare of small Tea growers and their workers.

Tea Board has provided the assistance of Rs.25.78 crore towards the welfare of the tea garden workers and their wards/dependents during the period from 2016-17 till 2021-22 (up to January, 2022) covering 36516 beneficiaries in All India.

The working condition of tea garden workers in the country are governed by the Plantation Labour Act (PLA), 1951. The Act requires the employers to provide the workers with housing, medical facilities, sickness and maternity benefits and other forms of social security measures. There are provisions for educational facilities for the children, drinking water, conservancy, canteens, creches and recreational facilities for the benefit of the tea plantations workers and their families in and around the work places in the tea estates. The welfare provisions of the Plantation Labour Act, 1951 have now been subsumed in two labour codes- the Occupational Safety, Health and Working Conditions Code, 2020 and Social Security Code, 2020. The Plantation Labour Act, 1951 is implemented by the State Governments.

There is no delay in disbursement of subsidy. Financial assistance of Rs. 119.03 crore has been provided by the Tea Board under the “Tea Development and Promotion Scheme” to the tea gardens of North Bengal during the last five years and current year [2016-17 till 2021-22 (upto January, 2022)]. Tea Board disburses subsidies to eligible tea stakeholders as per budget provisions and approved scheme guidelines. All cases where subsidy was sanctioned have been disbursed, hence there is no pendency.

A provision of Rs. 200.00 crore was provided in the Budget of Tea Board for 2021-22. Sanction process for Rs. 200.00 Crore under BE has not been completed.

(a) & (b): Yes Sir, MPEDA has adopted multipronged strategy to assist the aquaculture sector to recover from the crisis caused by the pandemic. Since January 2020 till December 2021 MPEDA has released Rs. 176.50 crores as subsidies for aquaculture development, production, promotion and export. To facilitate the aquaculture sector, all the services being provided by MPEDA such as export facilitation, registration of exporters, payments to suppliers, release of subsidies etc. were made online & validity of certificates were extended. The issues related to logistics, shortage/clearance of containers, delayed payments etc., were promptly addressed. In addition, Covid-19 guidelines booklet was issued to spread awareness on safety and hygiene in seafood, both forward and backward linkages were provided to aquaculture farmer, uninterrupted supply of inputs for fish hatcheries and farms and availability of raw and packing materials for the processing plants were ensured, Buyer Seller Meets were organized and an e-commerce platform was launched for better marketing of the shrimp. Due to these efforts, exports of marine products have registered a growth of 35% during April 2021- December 2021 as compared to the same period of previous year.

- (a) whether the Government has imposed mandatory discount clause for manufacturers of automobiles and tractors on GeM portal;
- (b) if so, whether these discounts are to the extent of 20% on tractors, 12% on utility vehicles and 15% on commercial vehicles whereas in DGS&D regime, mandatory discount was only 5 per cent;
- (c) if so, the grounds (study conducted, recommendations of committee, etc) on which such a huge discount are determined;
- (d) whether many latest models are not available on GeM portal on account of high discounts, which are preventing various Ministries/Departments from acquiring latest vehicles;
- (e) if so, whether huge discounts on these products are affecting the competitiveness of Indian companies to offer their modern/upgraded products on the GeM portal; and
- (f) if so, other steps being taken by the Government to rationalise mandatory discount regime on automobiles on GeM Portal to make it more competitive for domestic manufacturers?

(a), (b) & (c): No, Sir. Government has not fixed any minimum discount for manufacturers of automobiles and tractors on GeM portal. GeM takes decision regarding discounts based on consultation/interactions with various stakeholders including automobile manufacturers (OEM). Minimum discount for tractors and selective categories of automotive in GeM portal is as per table below:

- the quantum of value added agricultural products/ processed food items exported to various countries during each of the last three years and current year along with the net foreign exchange earned from such exports;
- whether the share of India in the global trade of value added agricultural products and processed food items is very low in comparison to other developing countries, if so, the details thereof and the reasons therefor;
- the steps taken to promote the export of processed food items from the country along with the incentives provided to exporters for the purpose during the said period; and
- whether the Government has taken any decision to permit the export of processed food even if a restriction is imposed on export of the basic farm produce and if so, the details thereof and the reasons therefor along with its impact on the prices of such goods in the domestic market?

- Details of India's exports of value-added agricultural products/ processed food items during the last three years and the current year are at Annexure.
- Data on share of India in the global trade of value-added agricultural products and processed food items is not maintained.

- (c) Promotion of exports of agriculture products, including processed food products, is a continuous process. The Government has taken several steps at State/ District levels to promote exports. State specific Action Plans have been prepared and State Level Monitoring Committees (SLMCs), Nodal Agencies for agricultural exports and Cluster Level Committees have been formed in a number of States. Country and product-specific action plans have also been formulated to promote exports. It has also been decided that the District as Export Hub Initiative of the Department of Commerce would be utilized to achieve the objectives of Agriculture Export Policy.

A Farmer Connect Portal has been set up for providing a platform for farmers, Farmer-Producer Organizations (FPOs) and cooperatives to interact with exporters. Buyer-seller Meets (BSMs) have been organized in the clusters to provide export-market linkages. Regular interactions, through videoconferences, have been held with the Indian Missions abroad, to assess and exploit export opportunities. Country specific BSMs, through Indian Missions, have also been organized.

The Government has also introduced a Central Sector Scheme – ‘Transport and Marketing Assistance for Specified Agriculture Products’ – for providing assistance for the international component of freight, to mitigate the freight disadvantage for the export of agriculture products.

The Department of Commerce provides assistance through several other schemes, to promote exports, including exports of processed food products viz. Trade Infrastructure for Export Scheme (TIES), Market Access Initiatives (MAI) Scheme etc. In addition, assistance to the exporters of processed food products is also available under the Export Promotion Schemes of Agricultural & Processed Food Products Export Development Authority (APEDA), Marine Products Export Development Authority (MPEDA), Tea Board, Coffee Board, and Spices Board.

- (d) Yes, Sir. The Agriculture Export Policy provides that the processed agricultural products will not be brought under the ambit of any kind of export restriction (viz. Minimum Export Price, Export duty, Export bans, Export quota, Export capping, Export permit etc.) even if the primary agricultural product is brought under some kind of export restrictions. This step is aimed at providing a stable policy environment for non-essential agricultural products and encouraging exports of processed/ value-added products rather than the basic commodities. As quantity of exports of value added agricultural/ processed food items vis-a-vis total domestic production is not very high, the impact on domestic prices is likely to be insignificant.

CLEARING OF EXPORT DUES

1195. DR. G. RANJITH REDDY:

Will the Minister of **COMMERCE & INDUSTRY** (वाणिज्य एवं उद्योग मंत्री) be pleased to state:

- (a) whether the Government plans to clear Rs. 56,000 crore dues owed to exporters under various Government schemes;
- (b) if so, the details of schemes under which Government owes to exporters and the number of MSME exporters who are going to be benefited from this;
- (c) the details of exporters from Telangana whose dues have to be cleared; and
- (d) the details of the efforts being made by the Ministry to achieve the target of exporting US \$ 400 billion in 2021-22?

- (a) & (b): Government has released Rs 56,027 crore in order to clear pending export incentive dues to exporters, which is for various Schemes namely: Merchandise Exports from India Scheme (MEIS) - Rs 33,010 crore, Service Exports from India Scheme (SEIS) - Rs 10,002 crore, Rebate of State and Central Taxes and Levies (RoSCTL) - Rs 5,286 crore, Rebate of State Levies (RoSL) - Rs 330 crore, Remission of Duties and Taxes on Exported Products (RoDTEP) - Rs 2,568 crore and other legacy Schemes like Target Plus Scheme (TPS), Focus Product Scheme (FPS) etc. - Rs 4,831 crore. This includes support for exports made under RoDTEP and RoSCTL Schemes during the 4th quarter of FY 2020-21. It is estimated that such benefits would be disbursed to more than 45,000 exporters, out of which majority would be in the Micro, Small and Medium Enterprises (MSME) category.

- (c): Clearance of dues under these Schemes is dependent on meeting the eligibility criteria by the applicant exporter, whose applications are scrutinized for any deficiency. Accordingly the detail of exporters' dues state-wise is not maintained.
- (d): To reach the target, some of the key schemes/interventions taken by the Government are:
- i. The Foreign Trade Policy 2015-20 has been extended upto 31.03.2022 to provide a stable regime during the COVID-19 pandemic, wherein Schemes such as the Advance Authorization Scheme and the Export Promotion Capital Goods (EPCG) Scheme are being implemented to enable duty free import of raw materials and capital goods for export production.
 - ii. Remission of Duties and Taxes on Exported Products (RoDTEP) Scheme has been introduced with a budget of Rs 12,454 crore for FY 2021-22.
 - iii. Rebate of State and Central Levies and Taxes (RoSCTL) Scheme for apparel and made-up exports has been extended till March 2024 with existing rates.
 - iv. Transport and Marketing Assistance (TMA) scheme for specified agriculture products is being implemented to provide assistance for the international component of freight and marketing of agricultural produce and to promote brand recognition for Indian agricultural products in the specified overseas markets.
 - v. A common digital platform for Certificate of Origin (CoO) has been launched to increase Free Trade Agreement (FTA) utilization by exporters.
 - vi. Monthly monitoring of exports for 200 countries and 31 commodity groups is being done.
 - vii. Under the aegis of "Azadi Ka Amrit Mahotsav", Vanijya Saptah was celebrated during 21-26th September 2021 to reach out to members of industry, exporters, association and State/Union Territory Governments for awareness and interaction on exports and various export related issues.
 - viii. In order to leverage full export potential , districts are being promoted as Exports Hubs by identifying products and services with export potential of each district.
 - ix. Exports of services is being supported through negotiating meaningful market access through multilateral, regional and bilateral trade agreements and through participation in and organization of international fairs/exhibitions like the Global Exhibition on Services.
 - x. An 'Action Plan for Champion Sectors in Services' to give focused attention to identified Champion Services Sectors through identified nodal Ministries/Departments is also in place.
 - xi. Assistance is being extended to exporters under the Market Access Initiative (MAI) scheme for various activities such as export market research, product development, product registration, organizing / participating in fairs, exhibitions and Buyer Seller Meets (BSMs) abroad, Reverse Buyer Seller Meets etc.
 - xii. In order to have a coordinated and focused attention on development of export infrastructure, a working group on infrastructure up-gradation has been constituted under National Committee on Trade Facilitation (NCTF) and a National Trade Facilitation Action Plan (NTFAP) has been formulated. This includes measures for improving road and rail connectivity to ports and smart gates at sea ports.

- (a) The online CoO system provides a transparent, paperless, contact-less system for issuance of CoO. The given system has been especially helpful during the Covid-19 pandemic to avoid disruptions to businesses. There are no specific operational issues in this regard. The online platform has 90 agencies, 241 offices, 641 issuing officers and 29,027 exporters on-board. Around 8.8 Lakh CoOs have been issued online till date, and around 3,000 CoOs are being issued daily.
- (b) Reference DGFT Trade Notice No. 32/2021-22 dated 24th January 2022, the issuance of Non-Preferential CoOs through this online system is not mandatory till 31st March 2022. The existing

system for submitting and processing Non-Preferential CoO applications in manual/ paper mode is permitted for the stated time period.

(c) & (d) - All feedbacks received from exporters and issuing agencies are duly taken note of and systemic improvements are being implemented from time-to-time. DGFT has a dedicated helpdesk mechanism for addressing any operation issue or guidance required by the exporters. The helpdesk is reachable through a Toll-free helpline number, through email and also through an online customer relationship management system available on the DGFT Website.

(a): Under the India-Mauritius Comprehensive Economic Cooperation and Partnership Agreement (CECPA) signed in February 2021 and implemented with effect from April 2021, Mauritius has offered import duty concessions to India's agricultural products

(b): At the WTO negotiations, India has been making efforts to obtain a permanent solution to the issue of public stockholding for food security purposes. On the issue of agricultural domestic support, India is of the view that the WTO Agreement on Agriculture provides considerable flexibility to the developed members to provide huge trade distorting domestic support and further, to concentrate the subsidies on a few products. This asymmetry needs to be addressed on priority in agricultural reform, however, without shifting the burden of reduction of agricultural subsidies to developing countries and preserving the special and differential treatment provisions in the agreement. In addition, India, along with other members, has been demanding Special Safeguard Mechanism (SSM) for developing countries, which is another mandated issue for agricultural negotiations at the WTO.

(c) & (d): A High-Level Advisory Group (HLAG) was constituted by the Ministry of Commerce and Industry to assess the global environment and make recommendations for boosting India's share and importance in global merchandise and services trade; managing pressing bilateral trade relations; and mainstreaming new age policy making. HLAG submitted its report in September 2019 containing macro recommendations as well as sector-specific recommendations, including for the agriculture sector.

- (b) : The data of skilled and unskilled workers is not maintained by Tea Board. As per the baseline survey conducted by Tea Board, the tea gardens employ 11,65,815 workers (7,02,832 permanent and 4,62,983 temporary).
- (c) to (e) : The Government provides broad framework for Corporate Social Responsibility (CSR) through Section 135 of the Companies Act, 2013 ('Act'), Schedule VII of the Act and Companies (CSR Policy) Rules, 2014. Schedule VII of the Act indicates the activities that can be undertaken by the company as eligible CSR activities. As per the Companies (CSR Policy) Rules, 2014, the entire CSR architecture is disclosure based and CSR mandated companies are required to file details of CSR initiatives annually in MCA21 registry. All data reported in MCA21 registry by companies on CSR, including the tea Sector Companies is available on National CSR Data Portal at www.csr.gov.in . The Development Sector-wise details of CSR expenditure by Companies including tea companies from financial year 2016-17 to 2020-21 is at **Annexure-II**.

(a) & (b): The mandate for the production, research, development, domestic marketing of spices except Cardamom is vested with the Union Ministry of Agriculture & Farmers Welfare. However, Spices Board is mandated with the export promotion of scheduled spices, including branded and value-added products and production & marketing of Cardamom. The primary sale of cardamom in India is carried out through auctions, which are governed by the Cardamom (Marketing & Licensing) Rules 1989 (as amended till 2018), framed as per the provisions of the Spices Board Act.

(c): In order to facilitate farmers in realizing the better price of their crops, the Board organizes Buyer Seller Meets in various parts of country, to establish direct market linkage between farmers and exporters/processors. In addition to this, Spices Board has introduced cloud based e-auction system for cardamom for transparency and better price discovery thereby ensuring remunerative price for the cardamom farmers. Further, Spices Board, with a view to empower the farmers to get better price realization and wider market for their produce, has established eight crop specific Spices parks in the production / market centers. The objective of the park is to have integrated operation for cultivation, post harvesting, processing and value addition, packaging and storage of spices and spice products.

(f) & (g): Yes, Sir. Article 32 of Asia Pacific Trade Agreement (APTA) has mention of withdrawal from the agreement. The article mentions, "Any Participating State may withdraw from this Agreement, such withdrawal to take effect six months following the day on which written notice of the same is served to the Participating States through the Executive Secretary of ESCAP. The rights and obligations of a Participating State which has withdrawn from this Agreement shall cease to apply as of that date. After that date, the Participating States and the withdrawing country shall jointly decide whether to withdraw in whole or in part the concessions received by the latter from the former and vice versa".

(a) & (b): Yes Sir. India is currently negotiating FTAs with the UK, EU, UAE and Australia. These agreements are comprehensive in nature and cover Trade in Goods, Services, Investments, Rules of Origin and other subjects.

(c) & (d): During the course of FTA negotiations, stakeholders including industry representatives, Apex Chambers of Commerce and Industry, Industry Associations as well as the Administrative Ministries and Departments are consulted from time to time. In order to protect the interests of the domestic industry, local traders and agriculture sector, FTAs provide for maintaining sensitive, negative or exclusion lists of items on which limited or no tariff concessions are granted. In addition, in case of surge in imports and injury to the domestic industry, a country is allowed to take recourse to trade remedial measures such as anti-dumping and safeguards on imports.

(a) to (d) : The import of toys, games, sports equipment is exhibiting a declining trend both from China and the World. In order to restrict the import of substandard toys, the Government has issued Toys (Quality Control) Order, 2020 on 25 Feb 2020 through which toys have been brought under compulsory Bureau of Indian Standards(BIS) certification with effect from 1 Jan 2021. This QCO is equally applicable to domestic manufacturer as well as foreign manufacturers who intend to export their toys to India.

The imports under FTAs are allowed subject to prescribed Rules of Origin criteria under ASEAN-India Trade in Goods Agreement (AITIGA).

The Central Board of Indirect Taxes and Customs (CBIC) monitors the imports and preferential arrangements made under Free Trade Agreements (FTAs) including the India – ASEAN FTA. CBIC has implemented Customs (Administration of Rules of Origin under Trade Agreements) Rules, 2020 from September, 2020. The purpose of these Rules is to streamline the implementation of trade agreements. The Rules are applied in cases of reasonable doubt on the origin criteria not being met.

The data of exports and imports of India with ASEAN countries during the last three years is annexed. (Annexure-I)

(e) The Government of India is in discussion with ASEAN countries for initiating the review of ASEAN-India Trade in Goods Agreement (AITIGA) to seek more market access for Indian products. Indian exporters are being encouraged to participate in trade fairs/exhibitions in ASEAN countries with financial support under Market Access Initiative (MAI) scheme of Department of Commerce. The market access issues and trade barriers being faced in ASEAN countries and China are being regularly taken up with individual countries through bilateral engagements. The Government has also launched schemes such as Production Linked Incentive Schemes (PLIs) to promote domestic manufacturing capacities in critical sectors such as Key Starting Materials/Drug Intermediates, Active Pharmaceutical Ingredients apart from electronic components & mobiles, white goods (ACs and LEDs), Specialty Steel, Drones and Drone Components etc. These schemes will promote domestic manufacturing capacities and attract investment and reduce dependency on imports from other countries.

(c): Textile including apparel exports constitute a significant share in India’s total exports. The share of textile and apparel exports was 10.52% of the total exports in 2021.

(d): Textile and Apparel export growth has been facing adverse impact of Covid pandemic and higher import tariffs in key markets such as European Union and United Kingdom as compared to zero duty access in these countries to competing countries like Bangladesh and Cambodia. Government has taken various supportive steps in this regard. Production Linked Incentive Scheme has been introduced for the sector with an approved outlay of Rs 10,683 Crore; Rebate of State and Central Taxes and Levies (ROSCTL) scheme has been extended and setting up of 7(seven) PM Mega Integrated Textiles Region and Apparel (PM MITRA) Parks has been approved to promote competitiveness of India’s textile and apparel exports. In addition, on going FTA negotiations will also provide more favourable market access to products exported from India.
