I.Introduction

- 1. It is imperative to monitor items of import basket to observe whether there are items which are consistently imported and contribute a significant amount in our import bill. A study has been conducted to identify import items which are consistently being imported, growing consistently and with significant share in value of imports at 8-HS digit level with a view to enhance domestic production capacity and to reduce import dependence.
- 2. Items driving high imports and having high value share in imports basket irrespective of seasonal and structural fluctuation in short-run (six months: March August 2021), medium-run (three years: 2018-19 to 2020-21) and long-run (ten years: 2011-12 to 2020-21) have been identified using the following criteria:
- 3. **Import Growth Drivers**: A filter of USD 10 million/ month (average, USD 120 million/ year) and an average import growth of items which are above the overall import growth of India (average in respective period) has been applied to identify items driving import growth.
- 4. **High Share in Value of Import:** Further, the imports having consistently high share, greater than 0.21%, amounting to an average import value of more than USD 1 billion annually (or USD 500 million for six months' period in short-run) across the three periods have also been analyzed.

II. Summary findings

- 5. **Growth drivers and high value share:** There are **102 items** which have been consistent import growth drivers or have held consistently high share across long, medium and short terms. Cumulative share of these 102 items is 57.66% in the total imports (Mar-Aug 2021). Out of these 102 items, there are **18 common items** which have both high share and high growth rate. Cumulative share of these 18 items is 25.60 % (Mar-Aug 2021). A detailed list of 102 items may be seen at *Annexure*. (The common 18 items are highlighted in bold in the list)
- 6. **Items under import growth drivers: 88 items** with share of 32.83% in total import in March-August 2021 have been identified that have exhibited consistent growth above average growth rate of total import basket with value of USD 10 million per month on an average in short, medium and long run. It may be noted that **275** items in the six-month period (Mar-Aug 2021), **289** items in last three years (2018-19 to 2020-21) and **274** items in the last ten years (2011-12 to 2020-21) have exhibited high growth.
- 7. **Items having high share in value of import:** In terms of share contribution, there are **32 such items** (including 18 items from the list of 88 items mentioned above) which have an average import value of more than USD 1 billion annually (USD 500 million for six

months' period in short-run) across the analyzed three periods and share of 50.43% in total imports of in March-August 2021.

III. Import items exhibiting high growth across study periods

- i. Common items (Short, Medium and Long run) in import basket: 88 import items showing surge were common in the three time phases. Major items are: Gold, Natural gas, Crude palm oil, Integrated circuits, Parts of telephonic/telegraphic apparatus, Personal computer, Urea, Phosporic acid, Crude soya-bean oil, Stainless steel scrap, Medicine, Sunflower seed oil, Turbo-jets, Lithium-ion accumulators, Refined copper, Machines and mechanical appliances, Cameras, Antibiotics etc
- ii. Short-Run Analysis (March-August 2021): 275 imports items exhibited a surge in the short run. Major items of import in latest six-month period which have registered surge are: Gold, Natural gas, Crude palm oil, Integrated circuits, Coking coal, Parts of telephonic/telegraphic apparatus, Personal computer, Fuel oil, Crude soya-bean oil, Urea, Base Oil, Copper ores Phosporic acid, Stainless steel scrap, Medicine, Turbo-jets, Lithium-ion accumulators, Cashew nuts, Refined copper, etc
- iii. Medium-Run Analysis (2018-19 to 2020-21): **289** items have exhibited a surge in the medium term and major items among these include: Gold, *Parts of telephonic/telegraphic apparatus*, *Aeroplanes*, *Monolithic integrated circuits*, *Crude palm oil*, *Personal computer*, *Turbo-jets*, *Urea*, *Crude soya-bean oil*, *Electronic integrated circuits*, *Aluminium scrap*, *Sunflower seed oil*, *Phosporic acid*, *etc*
- iv. Long-Run Analysis (2011-12 to 2020-21): 274 items have exhibited a surge in growth in the long run. Major items are: Non-industrial diamonds, Steam coal, Natural gas, Coking coal, Parts of telephonic/telegraphic apparatus, Crude palm oil, Aeroplanes, Personal computer, Urea, Crude soya-bean oil, Monolithic integrated circuits, Solar /Photovoltaic cells, Aluminium scrap, Sunflower seed oil, Turbo-jets, Cashew nuts, etc.

IV. Import items with consistently high share across periods

8. Out of the list of 11,987 item at 8 HS level, a list of **32** items have been identified which have an average import value of more than USD 1 billion (USD 500 million for six months' period in short-run) across the three analyzed time periods. (i.e. short, medium and long run).

V. Recommendations

- 9. Based on the study results, it is suggested that items showing high growth and/or high share i.e. a total of **102 items** with share of 57.66% in total import may be prioritized for immediate interventions for domestic production opportunities. As the data indicates these items have been demanded consistently for import in all periods and supply rigidities for these items in the domestic economy needs to be corrected. Detailed list of 102 items (with 18 common items in bold) is at **Annexure.**
- 10. Emphasis may be given to **18 common items** which have been consistently growing as well as hold a significant share consistently across the long, medium and short terms. (Cumulative share of 25.60% in Mar-Aug 2021).
- 11. Line Ministries/ Department (Indicative) of 102 priority items have also been identified and placed in the *annexures*.
- 12. Industry Associations, manufacturers and business leaders may consider exploring domestic capacity expansion in these items with a view to meet the unmet domestic demand which in turn will fuel economic growth and create employment opportunities.
