- (d) whether the Government has received any complaints regarding non-payment of remunerative prices to the farmers for their produces and some traders making huge profit out of such exports;
- (e) if so, the details thereof along with the action taken by the Government thereon; and
- (f) whether any corrective measures have been taken to provide benefit to the farmers in respect of the export and if so, the details thereof?

- (a) to (c) The details of agricultural products exported from the country during each of the last three years and the revenue earned from such exports are at Annexure-I. Country-wise details are at Annexure-II.
- (d) Department of Commerce has not received any such complaints.

- (e) Does not arise in view of (d) above.
- (f) In order to provide direct export linkage to farmers and to ensure that farmers benefit from exports, the Agricultural & Processed Food Products Export Development Authority (APEDA) is encouraging Farmer Producer Organisations (FPOs) to register as exporters and undertake exports. A number of FPOs have been registered as exporters all over India. A Farmer Connect Portal has also been set up for providing a platform for farmers, Farmer-Producer Organizations (FPOs) and cooperatives to interact with exporters.
