Minutes of the Meeting of the Empowered Committee (EC) of the Market Access Initiative (MAI) Scheme, held at 3:30 PM on 21<sup>st</sup> August, 2024.

A meeting of the Empowered Committee (EC) of the Market Access Initiative (MAI) Scheme was held at 3:30 PM on 21<sup>st</sup> August 2024 under the chairmanship of the Commerce Secretary. The list of participants is at **Annexure-I.** 

- 2. The Economic Advisor (E&MDA), Department of Commerce welcomed the participants and made a presentation of the MAI Scheme, briefly highlighting the broad contours of the Scheme, progress of the Scheme over the years, achievements under the Scheme in terms of activities organized and participation of Indian exporters in these activities, allocation and utilization of funds under the Scheme over the years, etc. She apprised the Committee that the Scheme was launched in FY 2002-03 and since its inception it has been playing an important role in promoting India's exports.
- 3.1 After the presentation, the items on the agenda of the meeting were taken up for discussion of the Committee. The decisions taken by the Empowered Committee on the agenda items are as under:
- 3.2 The EC noted the information placed before it.
- <u>4. Agenda Item No. 1:</u> Proposals received from the EPCs and Trade Bodies seeking assistance for undertaking export promotion activities during the financial year 2024-25 (for a period from October, 2024 to March, 2025).
- **4.1 Proposals for consideration of EC:** Approval of the EC is solicited for MAI assistance of ₹132.29 crore for 142 proposals (details at **Annexure-II**). The commodity-wise and region-wise summary of the events approved by the EC is as under (details at **Annexure-II**).

4.2 EC Decision: EC approved the proposal contained in para 4.1 above.

### 5. Agenda Item No. 2: Proposal for Ex-post-facto approval

- **5.1 Proposal for consideration of EC:** Ex-post-facto approval of the EC is solicited in respect of 8 export promotion activities of FY 2023-24 involving MAI assistance of ₹ 698.50 lakh to the EPCs and Trade Bodies, as per **Annexure-III.**
- **<u>5.2 EC Decision:</u>** EC deferred the proposal and advised the Sub-Committee to take a decision in this matter and inform the EC in its next meeting.

- 6. Agenda Item No. 3: Approval on Change in number of participants etc
- **6.1 Proposal for consideration of EC:** The approval of EC is solicited in respect of the approval for change in the number of participants for the events mentioned in the **Annexure IV**. Additional financial implication of these requests is ₹ 40.50 lakhs
- **6.2 EC Decision:** EC approved the proposal.
- 7. Agenda Item No. 4: Requests of some EPCs for approval of additional events during 01/04/2024 to 30/09/2024
- **7.1 Proposal for consideration of EC:** Earlier, EC in its meeting on 20/05/2024 approved 101 events amounting to ₹72.64 crores for the period April 2024 to September 2024. However, some EPCs have requested for additional events during April 2024 to September 2024 (Details at **Annexure-V**). The approval of EC is solicited for approval of 17 events from 15 EPCs with assistance of ₹ 11.32 Crore.
- <u>7.2 EC Decision:</u> EC deferred the proposal and advised the Sub-Committee to take a decision in this matter and inform the EC in its next meeting.
- 8. Agenda Item No 5: Proposal for prescription of a format for Claiming Airfare reimbursement under MAI Scheme 2021
- **8.1 Proposal for consideration of EC:** Para 7.3(6(ii)) of part IV of the operational guidelines of MAI Scheme 2021 provides airfare reimbursement to eligible Indian exporters for participation in events abroad and also for hosting foreign buyers in RBSMs in India. It provides maximum ceiling for individual participant as airfare reimbursement i.e. ₹ 1,50,000/- for Africa and American Countries and ₹ 90,000/- for other markets on 100% sharing basis as per revised rate in the Empowered Committee Meeting held on 4<sup>th</sup> May 2023.
- 8.2 The MAI Guidelines also states that the airfare reimbursement should be submitted in a format of Claim forms duly filled in and complete in all respects to the EPC concerned/ FIEO within 45 days of return to India. <u>However, no format for submission of such Claims has been prescribed under the said guidelines.</u>
- 8.3 Approval of EC was solicited for new proforma for submitted the proposals of airfare reimbursement claims.
- **8.4 EC Decision:** After deliberations, EC suggested to keep a simplified system because prescribing large number of documents and its scrutiny may consume a lot of time of the Department. The detailed scrutiny of the airfare claims/documents should be done by the respective EPCs as funds are being released to EPCs.
- 9. Agenda Item No.6: Proposals for revision/clarification of the Operational Guidelines of the Market Access Initiative (MAI) Scheme
- 9.1 Proposal for consideration of EC: Proposal regarding pro-rata cut in RBSM events in respect of lesser participation of foreign buyers:
  - **9.1.1** It is submitted that as per para 7.8 of the MAI Operational Guidelines, pro-rata and punitive cut would be imposed in cases where the number of participants is less than that approved by EC. It is silent about the differentiation in BSM and RBSMs. As per practice, in BSMs pro-rata cut is

imposed for participation less than EC approved numbers. In respect of RBSM events, the pro-rata cut is being imposed only in cases where there is reduced number of Indian exhibitors/participants. No pro-rata cut is being imposed if there is reduced number of foreign buyers in RBSMs. The rationale for not imposing pro-rata cut in respect of lesser participation of foreign buyers is that the reimbursement to foreign buyers/participants is made on actual basis subject to the prescribed ceiling limits.

- **9.1.2** A clarification was sought as to why pro-rata cut is not being imposed in cases of RBSM events in which there are less number of Foreign Buyers. The rationale for not imposing pro-rata cut in respect of lesser participation of foreign buyers is that the reimbursement to foreign buyers/participants is made on actual basis subject to the prescribed ceiling limits.
- **9.1.3** EC was requested to provide guidance regarding pro-rata cut in RBSM events in respect of lesser participation of foreign buyers
- **9.1.4** <u>EC Decision:</u> EC directed that division should take a appropriate decision in consultation with IFD.

### 9.2 <u>Proposal for consideration of EC: Clarification on imposition of pro-rata</u> cut in respect of variation in number of days of the event

- **9.2.1** The EPCs while submitting their proposals on MAI portal, they have to indicate the date(s) of the events as well. If there is any change in the dates of the events, they make the changes in the portal which are subsequently got approved by the competent authority at the time of finalization of accounts. At times, due to the uncertainty or otherwise, EPCs indicate some number of dates. In cases where the EPC indicated more number of days at the time of obtaining approval and actual event is held for a lesser number of days, a question was raised as to why proportionate cut to the actual number of days of the event is not imposed while finalising of accounts.
- **9.2.2** As per the MAI Scheme, the admissible amount is calculated proportionate to the number of participants. Number of actual days of the event is not taken into account while approving the amount. This proposal was placed in EC for consideration.
- **9.2.3** Proposal for consideration of EC: EC is requested to provide clarification if pro-rata cut proportionate to actual number of days of the event is to be imposed or otherwise.
- **9.2.4 EC Decision:** EC directed that division should take a appropriate decision in consultation with IFD.

### 9.3 <u>Clarification regarding imposition of pro-rata cut in respect of lesser participation in events approved by EC.</u>

- **9.3.1.** Para 3.1 of Operational guidelines for the MAI Scheme 2021, intera alia, prescribes a *minimum participation of 50 exhibitors/ exporters in activities abroad, for considering a proposal for approval.*
- **9.3.2.** In accordance with the above provision, EC at times approves the lesser number of participations from an EPC in an event abroad.
- **9.3.3.** At times, the participation from EPC is lesser than the reduced participants approved by EC. In such cases, the EMDA Division while finalizing the accounts, impose pro-rata cut/ punitive cut as applicable basis the number of participants approved by the EC.

- **9.3.4.** However, a doubt has been expressed that if participation is less than the EC approved reduced number participants, the punitive cut/pro-rata cut is to be calculated against the minimum participation prescribed under the guidelines irrespective of what EC approves.
- **9.3.5.** Proposal for consideration of EC: EC is requested to provide clarification if the pro-rata cut is to be imposed basis the reduced number of participants approved by EC or against minimum of 50 participants provided in guidelines.
- **9.3.6. EC Decision:** While approving events, EC also approves number of participants. EC directed that division should take an appropriate decision in consultation with IFD.
- 10. Agenda Item No. 7: Proposal for recognition as eligible agency under Market Access Initiative Scheme.
- **10.1 Proposal for consideration of EC:** The following organisations have requested for recognising them as eligible agencies for receipt of grant under MAI Scheme:
  - I. Millennial India International Chamber of Commerce, Industry & Agriculture (MIICCIA)
  - II. Institute of Charted Accountants of India (ICAI)
- III. IMC, Chamber of Commerce and Industry
- **10.2** Para 5.1. of the MAI Scheme 2021 dated 19/07/2021 provides that "Unless otherwise defined under a specific provision, the Scheme is open to the following Organizations/ Agencies:
  - i. Departments of Central Government, Organizations of Central/State
  - ii. Governments and Indian Missions abroad;
- iii. Export Promotion Councils recognized by Department of Commerce,
- iv. Commodity Boards under the Department of Commerce and other
- v. Departments/ Ministries of Central Government;
- vi. Apex Trade Bodies recognized under the Foreign Trade Policy;
- vii. Industrial 1 & Artisan clusters recognized by the State/ Central Government;
- viii. Institutions of National Importance (INIs) such as Indian Institutes of Technologies (IITs), Indian Institutes of Management (IIMs), National Institute of Designs (NIDs), National Institute of Fashion Technology (NIFT), Indian Institute of Foreign Trade etc.:
  - ix. Research Institutions/Universities/Recognized laboratories, etc., recognized by the Departments/ Ministries of Central Government.
- **10.3 Proposal for consideration of the EC**: EC is requested to provide the directions whether organizations may be included as eligible agency under the MAI Scheme or not.
- **10.4 EC Decision:** EC directed to examine these proposals with regard to the sectors they would cater, if there exists EPCs catering to same sector, their financial position, etc.
- <u>11. Agenda Item No. 8:</u> Request for consideration of the suggestion of 187<sup>th</sup> Report of DRPSC on Commerce regarding eligibility of exporters for claiming reimbursement of expenses incurred in connection with statutory compliances abroad.

- **11.1 EC Decision:** EC noted the suggestion and observed that introduction of the ceiling was introduced with an objective to promote small and medium exporters. Making it open to all types of exporters who can otherwise afford these costs would put pressure on the amount of assistance which has a limited budget.
- 12. Agenda Item No. 9: 7<sup>th</sup> Edition of Indus Food Event (RBSM) on 08/01/2025 to 10/01/2025 by TPCI.
- **12.1 Proposal for consideration of EC:** The Approval of EC was solicited for the proposal of TPCI for organising the 7<sup>th</sup> edition of Indus Food Event (RBSM) during 08/01/2025 To 10/01/2025 with an assistance of ₹ 600 lakhs which was recommended by the SC in its meeting held on 03/01/2024 is submitted for consideration of EC (**Details at Annexure-VI**)

EC Decision: EC approved the proposal.
