EXPORT OF ELECTRONIC GOODS

Will the Minister of **COMMERCE & INDUSTRY** (वाणिज्य एवं उद्योग मंत्री) be pleased to state:

- (a) the details of electronic items manufactured and exported from the country during the last five years and the current year;
- (b) whether the Government is considering to encourage export of electronic goods;
- (c) if so, the details thereof and steps taken for this;
- (d) the details of initiatives taken by the Government to encourage manufacturing of electronic goods in the country; and
- (e) the details of electronic companies set up under the scheme 'Make in India', particularly in the State of Jharkhand, State/UT-wise?

The current year (Apr – Oct 2024-25) export of Electronic Goods is Rs. 159,323 crores.

(b) to (c) To incentivize and promote exports in electronics, the initiatives taken by Government are as under:

Market Access Initiative (MAI) Scheme: The MAI Scheme plays a catalytic role to promote exports of Indian goods and services by providing financial support to eligible agencies to undertake necessary initiatives and projects. Such initiatives include support to micro, small and medium enterprises to enter export market; nurturing innovation; developing trade and market intelligence; building appropriate skill set; addressing the interventions required towards exploring new markets abroad. The Government encourages Indian exporters to participate in the exhibitions and provides grant-in-aid under this Scheme.

Government regularly monitors the export of all commodities, including Electronic Goods. Meetings are held with various stakeholders including Export Promotion Councils (EPCs), Exporters, Manufactures and Industry associations to understand the issues faced by the them and find out ways to resolve them. Regular meeting with Indian Missions and foreign counterparts are also held to resolve issues related to barriers to trade at bilateral and multilateral level.

(d) The Government has taken several measures to boost electronics manufacturing in the country and incentivize large investments in the electronic goods. The policy initiatives taken are:

1. Production Linked Incentive Scheme (PLI) for Large Scale Electronics Manufacturing
2. PLI for IT Hardware & IT Hardware 2.0
3. Scheme for Promotion of Manufacturing of Electronic Components and Semiconductors
4. Electronics Manufacturing Clusters (EMC) Scheme and Modified EMC Scheme
5. Modified Special Incentive Package Scheme
6. Electronics Development Fund
7. Phased Manufacturing Programme
8. Semicon India Programme
9. Scheme for setting up of Semiconductor Fabs

10. Scheme for setting up of Display Fabs

11. Scheme for setting up of Compound Semiconductors / Silicon Photonics / Sensors Fab / Discrete Semiconductors Fab and Semiconductor ATMP/ OSAT facilities and

12. Design Linked Incentive Scheme.

Apart from above Schemes, 100% FDI, exemption from Basic Customs Duty on capital goods, simplified import of used plant and machinery, Public Procurement (Preference to Make in India) Order 2017 and Compulsory Registration Order have also aided in growth of electronics manufacturing in the country.

(e) Under the 'Make in India' programme several initiatives have been undertaken by the Government leading to multiple electronics companies expanding their manufacturing operations in the country. These initiatives are pan India basis including state of Jharkhand.
