EXPORT FIGURES FOR TURMERIC

4254. SHRIK E PRAKASH

Will the Minister of **COMMERCE AND INDUSTRY** (वाणिज्य एवं उद्योग मंत्री) be pleased to state:

- (a) the export figures for turmeric from Erode and Bhavani carpets during each year from 2019-20 to 2024-25;
- (b) the export volume (in tonnes) and value (in Rs. crore) for each of the above product categories during the said period;
- (c) the export targets set for 2025-26 for these products and the measures proposed to achieve them; and
- (d) the specific initiatives taken by the Government to promote these GI-tagged products in international markets?

ANSWER

(a) to (d): Turmeric exports from India have increased from Rs 1,286.91crores in 2019-20 to Rs 2,885.39 crores in 2024-25. During the same period, the exports of Turmeric from Tamil Nadu (which includes Erode) have increased from Rs 162.53 crores to Rs 289.68 crores. The volume and value of turmeric exports for each year from 2019-20 to 2024-25 from India is provided at Annexure – I and from the state of Tamil Nadu is provided at Annexure – II.

Spices Board, under its schemes, undertakes various programs to promote the export of GI tagged spices, including GI tagged Erode Manjal (Erode Turmeric), which, interalia, include organization of Buyer Seller meets (domestic and international), participation in trade fairs and social media campaigns. Further, in order to harness the potential of turmeric and turmeric products, the "National Turmeric Board" has been constituted.

Carpet exports from India have increased from Rs 9724.84 crores in 2019-20 to Rs 13036.88 crores in 2024-25. During the same period, the exports of Carpets from Tamil Nadu (which includes Erode) have increased from Rs 108.63 crores to Rs 212.25 crores. The volume and value of Carpet exports for each year from 2019-20 to 2024-25 from India is provided at Annexure – III and from the state of Tamil Nadu is provided at Annexure – IV.

The Government has been providing financial assistance to various Export Promotion Councils and Trade Bodies engaged in promotion of textile exports, including Carpet exports & its GI tagged products, for inter alia organizing and participating in trade fairs, exhibitions, buyer-seller meets and awareness campaigns at national and international levels.
